Kindly refer to your office letter No. FC/HPB/06/69/2022 dated 15.07.2022 on the subject cited proposal.

2. The pointwise reply to the observations as raised vide your above referred communication is submitted as below:-

1. The authority letter has been uploaded against the column No.A-3 (xvii) in online Part-I.
2. The Administrative approval of project has been uploaded against the additional information details in online Part-I. copy of same is enclosed herewith.
3. The user agency has uploaded the brief note of the project against additional information details in online Part-I.
4. The user agency has been uploaded revised KML file marked alternative explored & SoI toposheet in distinct colours against column No. C (b) (ii) & (iii) in online Part-I. copy of same is enclosed herewith.
5. The user agency has submitted that all prospective/possible measures have been adopted which are essential to improve the grades of the road and accordingly the possibility of rectification of alignment from the desired points is not admissible.
6. The DFO concerned has submitted that the road alignment in KML file is passing through agriculture land and this land is a private land. There is no encroachment found on forest land. The Nakal Jamabandi and gift deed has been uploaded online against additional information details in online Part-I. copy of same is enclosed herewith.
7. The user agency has submitted that there is a provision of 2 No. slab culverts in the said road. The component wise breakup has been showing 2 No. Slab culverts against para B.2.4 in online Part-I.

8. The Soil Moisture Conservation Plan to protect the soil erosion as under:-



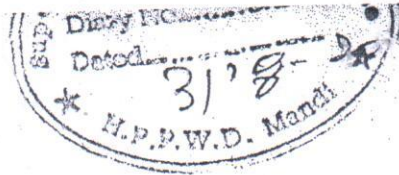
The user agency has submitted that all such areas vulnerable to erosion will be protected by providing breast walls as a mitigation measures at such location by the department.

9. The user agency has been marked both dumping site in KML file uploaded against column No. C (ii) (b) in online Part-I. Further user agency has submitted that the question of shifting the site to the non forest land does not arise at all as the possibility for the same have already been checked.
10. The user agency has submitted that the detail of trees i.e., Nil at the dumping sites which is enclosed herewith. However the detail of dumping site has already been placed in the proposal folder at Page No. 35.

21. The DFO concerned has submitted that the Status of proposed CA land is notified as UPF under IFA, 1927.
