With reference to the letter 7th cited, I am to enclose herewith the Muck Disposal plan in connection with diversion of 4.88 Ha of Forest Land in Vizianagaram Division for construction of Mini Hydel Project (3x4000 KW) 12.00 MW on Gomukhi River near Thonam Village of Salur Mandal, in favour of M/s Mohanarupa Power Project (Pvt.) Ltd, submitted by the Principal Chief Conservator of Forests & Head of Forest Force in the reference 8th cited for necessary action. He has informed that the proposed Muck Disposal area is outside the Nanda Reserve Forest area and located in the Power Project area under the control of the User Agency.
