Site Inspection Report of DFO

1. A proposal has been received by this office from PWD (R&B) Division Reasi for improvement and up-gradation of road from Kanda to Ransoo (under FCA, 1980) of 2.895 Ha of forest land for non-forestry purpose. The subject envisages the use of forest land for the improvement and up-gradation of road from Kanda to Ransoo. The site inspection of the land involved in the proposal has been done by me on 25-06-2021. On inspection of the site, it is found that the land required by the User agency is a forest land measuring 2.895 ha. The requirement of forest land is proposed by the user agency in Col.2 of part-I is unavoidable and is barest minimum required for the project.
