Site Inspection Report of DFO

- 1. A proposal has been received by this office from PHE Division Nowshera for diversion (under FCA, 1980) of 0.053 Ha of forest land for non-forestry purpose. The subject envisages the use of forest land for construction of Ground Storage Reservoir. The site inspection of the land involved in the proposal has been done by me on 21-06-2021. On inspection of the site, it is found that the land required by the User agency is a forest land measuring 0.053 ha. The requirement of forest land is proposed by the user agency in Col.2 of part-I is unavoidable and is barest minimum required for the project.
