Sub: Diversion of 4.16 ha of revenue forest land in Phatamunda village of Rampur Tahasil (within jurisdiction of Samablpur Forest Division) for construction of Adrsha Vidyalaya (Model School) Dunguripali in Subrnapur District, Odisha by District Education Officer, Sonapur (Proposal No. FP/OR/SCH/ 29971/2017).

In inviting a reference to F&E Department letter No.10F(Cons) 165/2018-21523/ F&E dated 05.10.2018 of Special Secretary to Government, Forest & Environment Department, on the mentioned subject the following point-wise compliances on the deficiencies pointed out are furnished below:-

(i) Justification for locating the project on forest land with details of alternative sites examined for the project as per provision of para 2.1 (vii) (3) of FC Act guidelines for avoiding/ minimizing use of forest land has not been provided.

In compliance to the above, the user agency has furnished the Justification for locating the project on forest land with details of alternative sites examined for the project as per provision of para 2.1 (vii) (3) of FC Act guidelines is enclosed as **Annexure-I**.

(ii) Basic information of Bolangir District/ Forest Division have been furnished in the FDP at Page 52-53. Since the project is to be established in Subrnapur District, basic information of Subrnapur District and Subrnapur Forest Division duly signed by APCCF (Nodal) shall be furnished.

In compliance to the above, the basic information of Subrnapur District and Subrnapur Forest Division duly signed by APCCF (Nodal) are enclosed as **Annexure-II & II (A)**.

(iii) Soft Copy of DGPS map of forest land proposed for diversion in CD form shall be furnished.

(iv) Employment (Regular/ temporary) likely to be generated owing to this project shall be indicated.

In compliance to the above, the user agency has furnished the employment (Regular/ temporary) likely to be generated owing to this project Model School, Dunguripali which is enclosed at **Page-IV**.

(v) C:B Analysis pertaining to this project, if required as per guidelines of MoEF & CC dated 01.8.2017 shall be furnished.




