In inviting a kind reference to the letter cited above on the captioned subject, the pointwise compliance of the discrepancies pointed out by your office vide letter under reference is furnished as under.

SI. No.	Discrepancies point out by the RCCF, Angul Circle	Compliance
1	As per online application, the diversion of forest land is 133.579 Ha. Accordingly, you have reported in the forwarding letter that 121.275 Ha. fresh diversion & 12.304 Ha. for re-diversion. But in your site inspection report it has been mentioned as 122.075 Ha. for fresh diversion & 11.504 Ha. for re-diversion. This may be clarified/rectified.	In compliance to this deficiency, this is to clarify that, due to clerical error fresh forest diversion for I22.075 ha. & re-diversion for I1.500 ha. has been mentioned in the inspection report. Hence the said error has been rectified after computation as 121.275 ha. for fresh diversion and 12.304 ha. for re-diversion. Accordingly a revised site inspection report is enclosed in the DP.
2	At page 21 of the Diversion Proposal, it has been mentioned that 121.275 Ha. of forest land require fresh diversion and 12.4407 Ha. for re-diversion, but at page 95 of the DP, it is shown as 12.304 Ha. for re-diversion. This may be clarified/rectified.	In compliance to this deficiency, the User Agency submitted that, actual fresh forest diversion is 121.275 ha. and forest rediversion is 12.304 ha. as per calculation sheet at page No. 102. Due to typing error forest re-diversion has been mentioned as 12.440 ha. at page No. 21. Accordingly page No.21 duly signed by all concerned is replaced & enclosed in the DP.
3	As per online application, non-forest land to the extent of 21.735 Ha. is included in the project, but in your Site Inspection it has been mentioned to 21.375 Ha. Further, the item-wise break up of total non-forest land comes to 20.939 Ha. This may be clarified/rectified.	clarify that, the extent of non-forest land is actually 21.735 ha as mentioned in the on line application. Due to type mistake, it has

4	At page 10 of the DP, non-forest land shown in the purpose-wise break-up to the extent of 21.375 Ha., but total non-forest land comes to 21.371 Ha. which may be corrected.	
5	The Map showing the road passing in Daitary PF & Tomka PF has not been signed by you.	In compliance to this deficiency, this is to clarify that, the Forest area involved in this Project is not a part of Daitary PF & Tomka PF. The User Agency wrongly Annexured the Map showing the road passing in Daitary PF & Tomka PF in the Diversion Proposal.
6	As per Col. No. 16 of the Site Inspection Report, "the Non-forest land used in the Project & non-forest land selected for Compensatory Afforestation is included in the DLC report or not". Accordingly the required information should be furnished as required."	In compliance to this deficiency, this is to clarify that, the non forest land used in the project has not been included in the DLC report. The non-forest land selected for Compensatory Afforestation (CA) - in Rayagada District has not been included in the DLC report, as per joint site verification report attached in the CA scheme at page 12 and submitted by the DFO Rayagada vide his office memo no 3846 dt. 14.09.2020.

In this context, Five sets of Forest Diversion Proposal along with the compliance is submitted herewith for recommendation to higher quarter for grant of Stage-I Forest Clearance.
