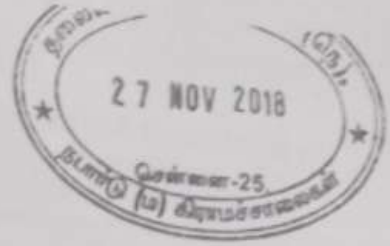

ABSTRACT

Highways Department – NABARD and Rural Roads – Upgradation of Panchayat Union / Panchayat Roads as Other District Road for the year 2018 – 2019 - Rs.882.62 crore – Administration sanction - Orders - Issued.

ORDER:

The Hon'ble Chief Minister has made the following announcement during the demand for Highways and Minor Ports Department on the floor of the assembly on 11.06.2018:-

"2000 Km length of Panchayat Union Roads / Panchayat Roads will be upgraded as Other District Roads at a cost of Rs.800 Crores".

2. Accordingly, the Chief Engineer (NABARD and Rural Roads), Highways Department has sent a proposal for upgrading 516 Roads for a length of 1538.98 Km at a cost of Rs.882.62 crore during the year 2018-2019 as per the road list received from the Director of Rural Development & Panchayat Raj, Chennai and requested the Government to accord administrative sanction.

3. The Government examined the proposal of the Chief Engineer (NABARD and Rural Roads), Highways Department and decided to accept the same, Accordingly, Government accord Administrative sanction for an amount of Rs. 882,62,00,000/- (Rupees Eight Hundred Eighty Two Crore Sixty Two Lakh only) for improving and upgrading of 516 Panchayat Union Roads / Panchayat Roads with a length of 1538.98 Km (as annexed to this order) and financial Sanction for a sum of Rs. 50.00 Crore for the year 2018 -2019.

4. The expenditure sanctioned in para -3 above shall be debited to the following Head of Account:-

"5054 – Capital outlay on Roads and Bridges – 04 – District and Other Roads – 337 – Road works – State's Expenditure – KD – Upgradation of Panchayat Union Roads / Panchayat Roads – 16.Major works"
(DPC 5054 – 04 – 337 – KD – 1600)

5. The expenditure sanctioned in para -3 above is an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending

approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (NABARD and Rural Roads), Highways Department is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G.-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department separately. He is also directed to send a draft explanatory notes for inclusion the above expenditure in the Supplementary Estimates 2018-2019 to Finance (BG-I/PW-I) Department without fail.

6. The Chief Engineer (NABARD and Rural Roads), Highways Department is hereby authorized to draw and disburse the amount sanctioned in para -3 above.

7. Orders for classification of the 516 Panchayat Union Roads / Panchayat Roads as Other District Roads listed in the Annexures will be issued separately.


