

JUSTIFICATION

Observation	Justification
<p>Alternative alignment and detailed comparative analysis along with justification for selected route and justification for selection of the forest land for this project shall be submitted. Also, the scope of transporting the water through <u>underground pipeline</u> may be explored.</p>	<p>Since construction of Head regulator need deep gorge portion with sufficient width between hill-lock, there is no such location available nearby. Also constructing Head regulator at selected location require minimum forest land to be diverted for this project. Hence no alternative alignment is possible.</p> <p>Since selected location is surrounded by Forest land, there is no scope for using private / government land for this project hence use of forest land is justifiable.</p> <p>Since there is proposed canal based small hydropower plant at this location transporting water through underground pipeline is not viable.</p>
