Vide ref 8th cited, the Government of India, Ministry of Environment Forests & Climate Change, Integrated Regional Office, Hyderabad has sought additional information for further consideration of the proposal, Accordingly information has been obtained from District Forest Officer, Nalgonda (DFO).

The details are as follows, with remarks:

Sl. No	Additional information	Reply
1.	The UA / DFO reported CA area as 1.18 ha, however, district collector reported as 3 acres i.e. 1.21 ha and in map it is mentioned as 1.2045 Ha	The area mentioned by the DFO is done through hand held GPS. However, after DGPS survey the extent of area is 1.2045 Ha which is authenticated by PCCF Office and the District collector has issued a letter to hand over the land to an extent of 3.00 acres ie., 1.21 Ha which is approximately near to the DGPS survey area. Hence, an area of 1.21 Ha towards CA NFL may be taken into consideration.
2.	The CA -NFL kml file uploaded is 22.8 ha.	It is a technical error in the ministry's portal. The CA-NFL land uploaded in the portal refers to the proposal no.FP/TG/ROAD/20352/2016 and while viewing the kml file in the portal the URL shows http://forestsclearance.nic.in/Admin/testmap1.aspx?type=cak&fname=0_0_21114121612_13_mapgps_CANFL.kml which is same as the URL of this proposal. However, correct CA NFL Kml file has been uploaded and can be viewed in the portal.
3.	To upload DFL map	The CA DFL Map has been uploaded in the additional information details at Part-II DFO level.

In view of the above, stating all the above facts the State Government are requested to submit the information to GoI, MoEF& CC, IRO, Hyderabad for consideration of this proposal.
