iii	Clear and high-resolution toposheet map of the proposed CA area as the one uploaded is least legible.	Attached as <b>Annexure -II</b> and the same has been uploaded in the parivesh portal Sl. No. 13 (iv) of Part-II
iv	Undertakings for the payment of compensatory levies such as CA, NPV, Addl. NPV, Wildlife Management plan etc. by the User Agency.	All undertaking attached as <b>Annexure-III</b> . Also uploaded by user agency in parivesh portal additional information details of Part-I.
v	Detail of the trees proposed for felling and proposed for translocation out of total no. of trees (260) enumerated in the forest land proposed for diversion.	Division Forest Officer has reported that the Nos. of tree proposed for felling is 260 nos. Nos. of trees proposed for translocation is Nil.

Division Forest Officer has reported that the gross area 29.00 ha. is sufficient for planting 20210 plants i.e. 1000 plant/ha. and the identified CA area is free from all the encumbrances.
