- 2. The pointwise reply of the observations as raised vide letter under reference is as under:-
 - 1. The component wise breakup has been revised online.
 - 2. A copy of visible Layout Plan is enclosed herewith.
 - 3. A certificate/ undertaking in this regard is enclosed herewith.
 - 4. There is no trees standing on the proposed muck dumping sites a certificate/ undertaking in this regard is enclosed herewith.
 - In this regard it is submitted that Paradi village is also a part of Gram Panchyat Pichlihar for which FRA has been obtained. Further, initially the proposed forest land was 1.5461 ha. for which FRA certificate was obtained from DC, Kullu. After reassessing the technical feasibility of the project, the proposed land was reduced to 0.5705 ha. due to the following reasons:-
 - (i) Initially T/ line was proposed overhead with ROW 15 mtrs. which has now been proposed underground with width 60 cms.
 - (ii) The width of WCS has been reduced from 2 mtr to 1 mtr.
 - (iii) 1200 mtrs long ropeway proposed earlier has been removed.
 - (iv) Power House which was earlier proposed on forest land has now been proposed on private land.
