

**Recommendation by Chief Conservator of Forests, Wildlife and Field Director,
Project Tiger Ranthambhore, Sawai Madhopur
(For the Forest land to be diverted under FCA)**

Name of Project:- Widening, Strengthening and Reconstruction of Sawai Madhopur-
Shivpuri Road (SH-30) –

Online Proposal No. FP/RJ/Road/16889/2015

A proposal has been received by this office from the Dy. Conservator of Forests and Dy. Field Director First, Project Tiger Ranthambhore, Sawai Madhopur for diversion (under FCA- 1980) of 6.86 ha. of forest land for non-forestry purpose. The subject envisages the use of forest land of Widening, Strengthening and Reconstruction of Sawai Madhopur- Shivpuri Road (SH-30)

The site inspection of the land involved in the proposal has been done by me on date 8th May 2017. On inspection of the site, it is found that the land required by the user agency is Reserved Forest land measuring 6.86 ha. in a linear strip of 7 mts. width. The Reserved Forest land is also notified as a Sanctuary and Critical Tiger Habitat under the provisions of the Wild Life (Protection) Act, 1972. The legal status of the land involved is further clarified as 'Reserved Forest' notified under The Rajasthan Forest Act, 1953. It is also notified as 'Reserved Area' under the provisions of The Rajasthan Wild Animals and Birds Protection Act., 1951. It is also notified as 'Critical Tiger Habitat' under The Wild Life (Protection) Act, 1972 as amended in 2006.

The requirement of forest land as proposed by the user agency in Col. 2 of part-I is unavoidable and is barest minimum required for the project.

Whether any rare/endangered/unique species of flora and fauna is found in the area. If so, the details there of: **Yes, rare endangered fauna species like Tiger, Leopard, Sloth Bear, Sambar, Caracal are found in the area**

Whether any protected archaeological/heritage site/defense establishment or any other important monument is located in the area. If so, the details thereof with NOC from competent authority, if required: **No**

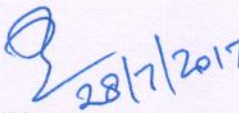
It is also stated that the user agency has not violated the provisions of Forest (Conservation) Act, 1980 and no work has been started without proper sanction.
