This is w.r.t. to the online EDS/shortcomings have been noticed by the Deputy Inspector general of Forest(Central) dated 12.5.2025 on the subject cited above.

2. In this regard, it is intimated that, the proposed proposal for diversion of 25.6 hectare of forest land for the construction Bhaba Mud Sagam Attaergoo road km. 0/0 to 44/400 in which (**Portion Km. 0/0 to 7/o area 4.80 ha.**) passes through territorial) As per the shortcomings raised by the above reference regarding the forest clearance proposal under FCA.1980 for the construction of Bhaba Mud Sagam Attaergoo road the point wise EDS/shortcomings replies are submitted as under:-

State Govt. shall upload the legible and in scale format layout showing all the components in distinct colors, duly authenticated by DFO concerned. 	sought from state Govt. In reference to this, State Govt submitted that the plan has been uploaded, however same not sound uploaded. Therefore, State Govt shall submit the conservation plan as per HP Road Policy for all existing water sources and drain within and adjacent to this site, duly authenticated by DFO concerned.	authenticated by the DFO concerned uploaded in additional column of Sr. No.12
4	In reference of the observation No. 13, Reply is not accepted, separate enumeration list of trees for the dumping site was sought from the State Govt, however same not found uploaded. State Govt shall upload the complete enumeration detail of trees of the dumping sites of both the divisions, duly authenticated by DFO concerned.	It is intimated that the certificate for the tree standing in the dumping sites from the concerned DCF/DFO concerned (WL/Territorial) now been uploaded in additional column of Sr. No.13-14
5	In reference of the observation No. 14, Reply is not accepted, NPV bill/ calculation sheet has been submitted for Eco Class-VI , vegetation density-open, however as per the S.No-4 (i), part-II vegetation density is mentioned as 0.5 which comes under dense forest (Rs. 13,72,410). Therefore, State Govt shall submit the revised NPV bill/ calculation sheet as per the dense vegetain density as mentioned in S.No-4(i), Part-II.	Revised NPV/calculation sheet has been prepared on the basis of the Eco- class-VI pertaining to Kinnaur Forest Division amounting to Rs. 5133456/- uploaded as addition information column of sr. No. 11 in part-II
6	In reference to the observation No. 15 reply is not accepted, muck management plan has been submitted however, no reclamation plan found uploaded. Therefore, State Govt. shall upload the complete reclamation plan with protection measures with finical outlay.	Necessary rectification has been done by the UA and uploaded as addition column in Sr. No.25
7	In reference of the observation No. 23, Reply is not accepted, as per the DDS, state Govt proposed the DFL in 51.6 ha, however calculated area is 19.2 ha. Out of 9.60 ha (WL Sarahan) 01 ha is under very dense Forest category (VDF) and in Kinnaur Forest Division, out of 9.60 ha, 04 ha in under Moderate Dense Forest Category MDF. Also, the shape of the uploaded KML of the CA area is not matching with SOI, DGPS WL Sarahan Division. Therefore, state Govt. shall upload the correct and complete area of the proposed compensatory afforestation area with vegetation density less than 40 % with requisite documents (KML, SOIL & toposheet, Land suitability certificate, Compressive CA scheme, revenue records etc.) duly authenticated by DFO concerned.	In rectification of above reply in all the compensatory afforestation scheme comprising area 9.60 ha. Proposed in DFL has been changed and re-proposed in area of Musarang Beat of Katgoan Range, under the jurisdiction of Kinnaur Forest Division an uploaded as Appropriate column in Part-II
