For the violation, notice has been sent to the user Agency and the User Agency deposited the penalty amount of Rs.1,97,468/- (One lakh ninety seven thousand four hundred and sixty eight) in CAMPA account on 06.12.2018. This details have already been uploaded by the DFO, in the section 11 of Part-II of Form A.
