Sub: - Proposal for diversion of 22.258 ha. of balance forest land including 8.583 ha. for Safety Zone as per Sabik settlement record as on 25.10.1980 in respect of its Talangi-A Chromite Mines in village –Talangi & Ostapal in Sukinda Tahasil of Jajpur District, of M/s IDCOL.

In inviting a kind reference to the above cited subject, it is to inform you that 34.594 Ac.(14 Ha.) of non-forest Govt. land has been identified & selected for compensatory afforestation in mouza –Madhupurgarh under Dharmasala Tahasil of Jajpur District in lieu of equal extent of forest land diverted against Talangi- A Chromite Mines of M/S IDCOL. The details of the land scheduled is furnished below.

The identified Non-forest Govt. Land has been jointly verified and demarcated in the field by erecting four feet height of RCC pillars. The said plots identified for CA have not been mentioned in DLC list. The user agency (UA) has submitted the DGPS map along with KML files & shape files in CD form.

For taking up compensatory afforestation, the scheme has been prepared at the current wage rate @311/- of financial forecast of Rs 1,05,54,461.00. Accordingly, the CA scheme has also been enclosed in the diversion proposal as Annexure- XVIII.
