Vide ref 22th cited, the GoI, MoEF & CC, New Delhi has sought additional information on the subject proposal for further consideration of the proposal.

Accordingly, vide ref 24th cited, the District Forest Officer, Mancherial has forwarded the reply submitted by the SCCL as desired by the GoI, MoEF & CC, New Delhi.

Further, the District Forest Officer, Mancherial has informed that the M/s SCCL vide reference dated 02.08.2023 has submitted (4) sets of "Undertaking" on Rs.100/- & Rs.20/- Bond papers to handover the non-forest land as CA (Dump Area) which is equivalent to the diverted forest land i.e., 162.457 Ha in favour of State Forest Department during the year 2026-27 (Copies of undertakings enclosed). M/s SCCL vide reference dated 01.09.2023, has submitted "Non-Encumbrance Certificate" issued by Tahsildar, Naspur Mandal stating that "the 162.45 Ha Non forest land area is in possession of M/s SCCL, and it is free from any encumbrances, the said land is registered and mutated in favour of M/s SCCL, in revenue records(copy enclosed).

DFO Mancherial further informed that as per field inspection with the Forest Divisional Officer, Mancherial and concerned Forest Range Officer and staff following observations were made.

- Land demarcated with flags on ground is corresponding to DGPS stations
- Abstract of year wise plantations carried out by SCCL is attached.
- Recent year plantations are to be revisited to improve green cover and fill blanks.
- Site canopy density of the Non-forest land is 0.1-0.4.
- Approach roads are made to carry out the planting activities.
- SMC, WHS are absent in the site, however the site is undulating and small water storages found in between soil mounds.
- On CA site, within the DGPS stations, there is no encroachment.
- Two High tension power transmission lines are passing above the Non-forest land on banks of Godavari river. Further, as site is on banks of Godavari river, there is significant soil erosion and plain area is susceptible to flooding. On cross checking with google imagery and field data of SCCL, Godavari has not flooded the CA site in recent incidents of flooding.
- CA Site is on reclaimed area of Overburden dumps. There are benches of 30 meter height and the top height is 90 meters above the ground level. Dumps are stabilized using grass broadcast, however deep rills are formed and soil is

washed away along slopes due to which severe degradation is observed. Slope stabilization is a concern and attention to be paid to same by the SCCL.

- Ungulate signs are observed in the dump area including peafowl movement . Due to presence of Nalla tumma on Godavari banks an other favorable conditions avian population is healthy at site. The nearest forest patch is 3 km away and with the recently proposed 162.45 Ha mining area, forest patch will be 4.5-5 km away. Hence the CA site is disjointed from the forest. there are signs of wildlife presence in the area. This reclaimed patch will be useful to accommodate the remaining wildlife which is going to be affected by the proposed expansion of OCP (the 162.45 Ha proposal).

In view of the above, stating all the above facts the State Government are requested to forward the above information to Gol, MoEF& CC, New Delhi for consideration of this proposal.

In compliance to the reference 13th cited above wherein the Prl.Chief Conservator of Forests, TS, Hyderabad had instructed to submit the additional information regarding the 162.45 Ha Non forest land details sought by MoEF & CC New Delhi.

Accordingly the M/S SCCL had vide reference cited 14th above had submitted 4 sets of “Undertaking” on Rs.100/- & Rs.20/- Bond papers to handover the non-forest land as CA(Dump Area) which is equivalent to the diverted forest land i.e, 162.457 Ha in favour of State Forest Department during the year 2026-27.(Copies of undertakings are attached herewith.)

Further it is submitted that vide reference 15th cited above the undersigned has instructed M/S SCCL to ensure that the 162.45 Ha Non-Forest land is free from any encumbrances and the said land is mutated/registered in favour of M/S SCCL in Revenue records and to submit a Certificate stating the same to the O/o.DFO, Mancherial.

Further it is submitted that the M/S SCCL vide reference 16th cited above, has submitted “Non-Encumbrance Certificate” issued by Tahsildar, Naspur Mandal stating that “the 162.45 Ha

Non forest land/area is in possession of M/S SCCL and it is free from any encumbrances, the said land is registered/mutated in favour of M/S SCCL, in revenue records.”(Copy of the same is attached herewith.)

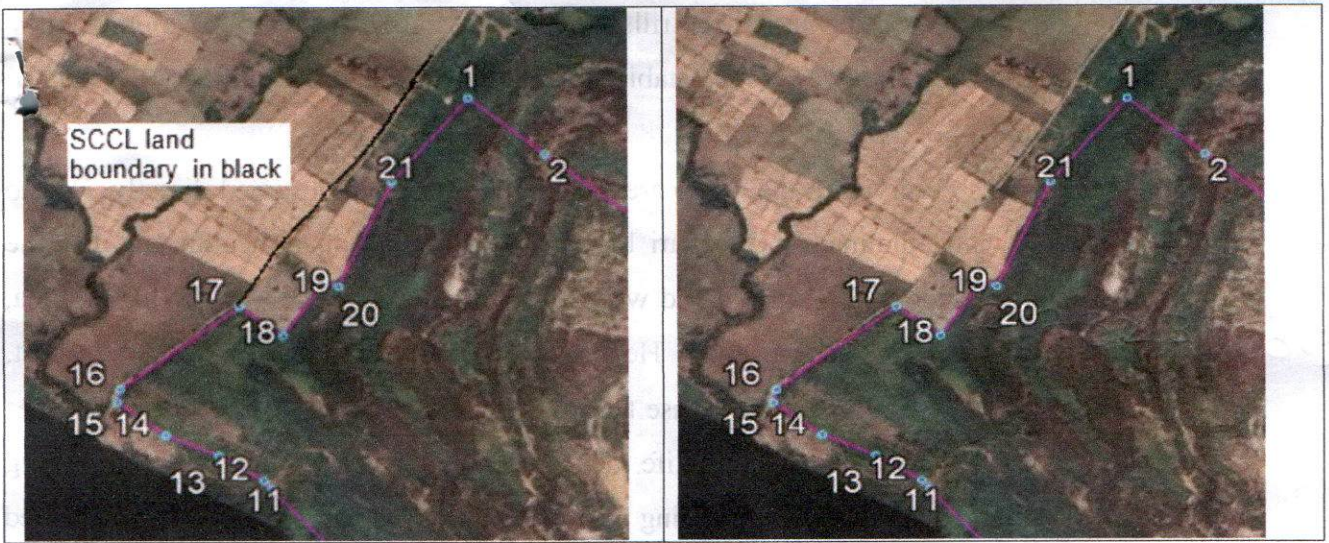
Further it is submitted that as per field inspection with the Forest Divisional Officer, Mancherial and concerned Forest Range Officer and staff following observations were made,

- Abstract of year wise plantations carried out by SCCL are shown as below :

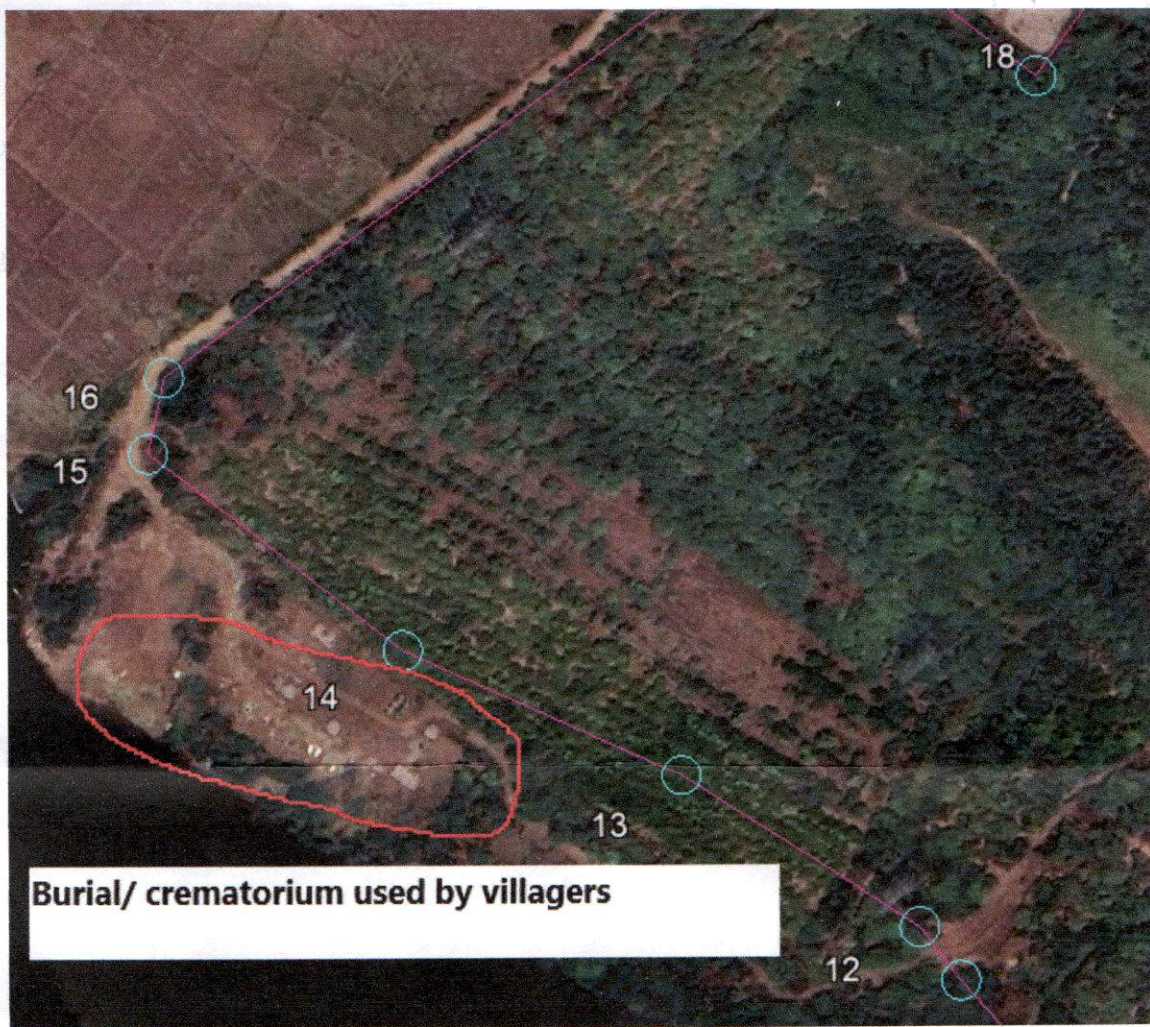

- Recent year plantations are to be revisited to improve green cover and fill blanks.
- Site canopy density of the Non-forest land is 0.1-0.4.
- Approach roads are made to carry out the planting activities.
- SMC , WHS are absent in the site , however the site is undulating and small water storages found in between soil mounds
- As per revenue record produced, SCCL has submitted “Non-Encumbrance Certificate” issued by Tahsildar, Naspur Mandal stating that “the 162.45 Ha Non forest land/area is in possession of M/S SCCL and it is free from any encumbrances, the said land is registered/mutated in favour of M/S SCCL, and therefore in revenue recordst the site is free of encumbrances and encroachments. On site, within the DGPS stations no encroachment observed, However, on boundaries of the land proposed following are observed :

Between stations cultivation 17, 18, 19 in the SCCL land, it is found that villagers are cultivating, it is enquired and villagers report that some compensation money dispute is with SCCL and between the cultivators.



- Further, South-west side of the Non-forest land on the banks of river Godavari there is Burial ground and Crematorium is used by Tallapalli villagers since long time.



- Therefore, The User agency has to ensure to take preventive/mitigate measures to stop further encroachment of the Non-forest land before the handover, if any, to state forest department.
- Two High tension power transmission lines are passing above the Non-forest land on banks of Godavari river. Further, as site is on banks of Godavari river, there is significant soil erosion and plain area is susceptible to flooding. On cross check with google imagery and field data of SCCL, Godavari has not flooded the CA site in recent incidents of flooding.
- Site is reclaimed area of Overburden dumps, three benches of 30 metre height are observed and the top height is 90 metres above the ground level, Dumps are stabilised

using grass broadcast, however deep rills are formed, soil is washed away along slopes, severe degradation observed. Slope stabilisation is a concern and attention to be paid to same by SCCL.

- Ungulate signs observed in the dump area, peafowl movement observed directly. Due to presence of nalla tumma on Godavari banks, avian population is healthy at site. The nearest forest patch is 3 km away and with the recent proposed 162.45 Ha mining area, forest patch will be 4.5-5 km away. Hence, the CA site is disjointed from the forest, however the wildlife is observed to use the green cover, tree cover and as water sources are nearby, there are signs of wildlife. This reclaimed patch will be essential, going forward, to accommodate the remaining wildlife south of NH 63, which will be affected by the proposed expansion of OCP (the 162.45 Ha proposal).
