Examination of revised KML of proposal alignment over Google Satellite imaginary, it has been found that total length of proposed alignment is 250 meters and accordingly area proposed for diversion is calculated to be 0.025 hector. State Government may revisit the area required for diversion or length of proposed alignment.
