Sub:- Submission of Proposal for Diversion of 7.043Ha. of Forest Land for Widening and Strengthening of Raruan-Fagu-via-Ghagarbeda Road from 0/000km to 25/000km under the jurisdiction of Karanjia Forest Division in the District of Mayurbhanj.

Ref:- Memo no.16017, dt.08.09.2022 of OSD-cum-Special Secretary to Government, FE&CC Department, your memo no.17954, dt.13.09.2022 and memo no.4511, dt.21.09.2022.

In inviting a reference to the above cited memo on the captioned subject, the Divisional Forest Officer, Karanjia Forest Division vide his memo no.4510, dt.21.09.2022 has furnished point-wise compliance report on the observation made by the Government of India, MoEF & CC, IRO, Bhubaneswar vide no.5-ORC527/2022-BHU, dt.02.09.2022 to this office which is furnished below for your information and necessary action.

Point No.01: The User Agency has not furnished the Shape/KML Files entire Stretch of road alignment proposed for Widening with proposal.

Compliance: In compliance to the point the Divisional Forest Officer, Karanjia Division has submitted the Shape/KML Files of entire Stretch of road alignment proposed for Widening in form of CD which is enclosed herewith.

Point No.02: State Govt. has reported that elephants and other wildlife are noticed in the area. However, to mitigate the impact on elephant and other wildlife habitate, measures have not been recommended.


Compliance: In compliance to the observation, the Divisional Forest Officer, Karanjia Division has reported that the proposal for diversion of forest land has been applied only for widening of the existing road not for a new road. The elephants and other wildlife are occasionally noticed in that area and no elephant corridor in the nearby area of the proposed road. However, there is no impact on wildlife habitat but occasionally some migratory wildlife are noticed.

Point No.03: As per DSS, the proposed CA area is 2.17km away from nearest the Gambharia RF. How far the management of the C.A are of 7.043ha. will be feasible may be furnished.

Compliance: The Divisional Forest Officer, Karanjia Division in his compliance report has reported that Proposed Compensatory Afforestation area is suitable for plantation for Management point of view. Provision of watering & adequate fencing has been provided in the scheme.




