With reference to the aforementioned memo on the captioned subject, the point wise compliance report is furnished below.

2. *In your forwarding letter, you have stated that the above diversion proposal has been scrutinized as per the general approval accorded for the aforesaid project vide F.No.11-09/98-FC dated 16.10.2000 of Govt. of India, MoEF&CC. But it is seen that, in the aforesaid general approval, critical public utility and welfare projects like Schools / Educational institutions do not find place. Please clarify.*

The above diversion proposal has been scrutinized and sent herewith for approval / permission of the State Govt. under section 2(ii) of FC Act, 1980 in pursuant to the General Approval of guideline vide F. No.11-9/98-FC dated 13.05.2011 and as per Para 4.4. (4.4.1) of the Hand Book of Fc Act, 1980.

3. *Whether the above project involves any Non-forest- land or not has not been mentioned.*

The above project has not involved any non-forest land.

4. *The latitude and longitude of the area proposed for diversion has not been given.*

The latitude and longitude of the area proposed for diversion is furnished in the Topo sheet map No.F45H12 as well as Geo reference map which are enclosed in the DP.

5. *Certificate under FRA, 2006 has not been furnished.*

The project proponent has submitted an undertaking that, Certificate under FRA, 2006, if required on lieu of diversion of 2.158 ha of forest land proposed for diversion.
