
Kindly refer to your office letter No . FC/HPB/06/66/2022 dated 11-08-2022 on the subject cited above.

2. The point wise observation raised vide above referred communication is attended as under:-

1. The copy of Administrative Approval has been uploaded online Part-I.
2. The brief note of the project has been uploaded at Sr. No. 2 against additional information detail of Part-II.
3. The revised KML file showing all the villages has been uploaded at Sr. No. 2 against additional information detail of Part-II.
4. In this regard it is submitted that 0.734 Km road will pass through non-forest (private) land. Hence, there is no any encroachment on the forest land.
5. The revised layout plan has been uploaded at Sr. No. 2 against additional information detail of Part-II.
6. The revised KML file has been uploaded against appropriate column of Part-I.
7. CCF Chamba has submitted that the existing path shown in the KML is not a road, it is just a footpath which is being used by the villagers to carry the material from one village to another village only.
8. The revised NPV bill has been uploaded against the additional information detail of Part-II.
9. The necessary enumeration list alongwith abstract of trees coming in the alignment of the road duly authenticated by DFO has been uploaded at Sr. No. 2 against additional information detail of Part-II.
10. In this regard it is submitted ~~by~~ the user agency that GI wire crate in multiple layers shall be provided as per site condition and requirement during the construction phase.

11. It is submitted that full efforts were made by the user agency and all the possible alternative explored were considered by the joint inspection team and this alternative which was best suitable, having minimum requirement of forest land as well as trees is finalized. Further, it is also submitted that the local habitant area holding <sup>is</sup> very less land which is only sufficient for <sup>his</sup> livelihood they did not agree for donating their land for the dumping sites.
12. The muck Management Plan duly authenticated by DFO has been uploaded against additional in online part-II with this reply.
13. Reclamation Plan has been uploaded against additional in online part-II with this reply
14. Needful has been done and has been uploaded against additional in online part-II.

16. The necessary correction has been done against appropriate column of Part-II.
17. Revised KML file incorporating this has been uploaded by the User Agency against appropriate column.
18. NoC/Sale deed for non-forest land acquired form private individuals has been uploaded against additional in online part-II with this reply.
19. It has been submitted by the User Agency that all necessary steps to mitigate the soil erosion will be taken during the preparation of DPR.
20. Needful has been done against appropriate column.
21. The necessary updation has been made against appropriate column.
22. DFO has submitted that all efforts to minimize the use of forest land as well as felling of trees has been made and re-joint inspection has already been carried out under the chairmanship of undersigned on dated 03.09.2021. Hence is one is best suitable alignment for construction of this road considering all aspects.
23. The revised CA site Map, KML and toposheet map have been uploaded against the additional information of Part-II.
24. The necessary correction has been done against appropriate column.
