In inviting a kind reference to your aforecited memo on the captioned subject, the Divisional Forest Officer, Keonjhar(WL) Division vide his memo no.3047, dt.23.08.2022 has submitted the documents as desired by Sri Sandeep Nandi, Scientist-B, MoEF & CC, GoI, IRO, Bhubaneswar vide his No.5-ORB506/2022-BHU, dt.04.04.2022 which is furnished below:

1. A certificate from District Collector to NTCA regarding non-availability of land suitable for relocation of the villages located within the Protected Area and Tiger Reserve before any proposal of relocation within the forest is approved.

The Divisional Forest Officer, Keonjhar(WL) Division has submitted Certificate given by the Collector, Keonjhar on non-availability of non-forest land for settlement of villages like Pitanau, Ratnamara, Jhunapasi after relocation from Hadgarh Wildlife Sanctuary(**Enclosed as Annexure-A**).

2. Clarification on the extent of land de-reserved/de-notified for resettlement shall not be more than the extent vacated by the settler in the core area.

The Divisional Forest Officer, Keonjhar(WL) Division has submitted the report furnished by the Tahasildar, Hatadihi Tahasil duly authenticated by the Tahasildar, Hatadihi and DFO, Keonjhar(WL) Division(**Enclosed as Annexure-B**).
