CA Site Map Retwar Drain RD 80-101 R/Side

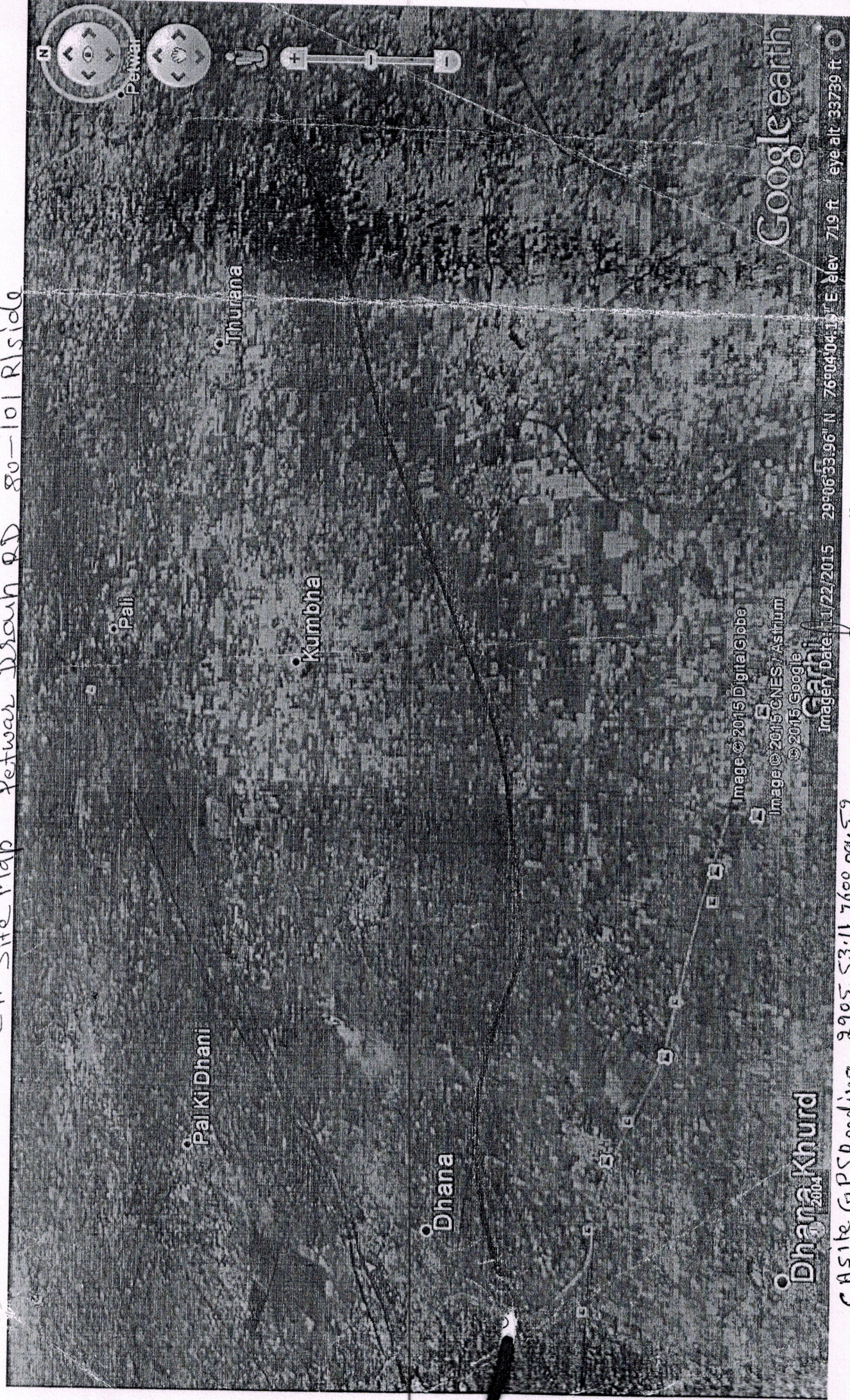
