In compliance of the Ministry of Environment and Forests(MoEF), Government of India's letter no. 11-9/98-FC(pt) dated 3rd August'2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act,2006('FRA', for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February'2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that **27.34 hectares** of forest land proposed to be diverted in favour of "Department of Power, Govt. of Arunachal Pradesh, Itanagar for "Construction of 33 KV Miao-Kharsang distribution line" under Comprehensive T & D Scheme of Arunachal Pradesh falls within Nampong Forest Division under Changlang District.
