Kindly refer to your office letter No.8B/HP/06/46/2019/FC/64 dated 15.04.2019 on the subject cited above.

2 The pointwise reply of the observations as raised vide your above referred letter is submitted as below:-

1. Joint justification has been submitted by UA and DFO that alignment of the proposal road were found feasible by the joint inspection committee during joint inspection because there were non availability of non forest land as well as no other alternate alignment except government land were technically feasible to link Village Gouncha (Gyan). There is no chance to reduce the diversion area of proposed road, no scope of revised enumeration of trees and no scope of change geo-referenced map of the proposed road. The alignment is technically feasible in all of view. Hard copy of same is enclosed herewith.
2. Comments of CWLW are enclosed herewith.
3. A joint justification has been submitted by the UA and DFO that there are no possibility to shift dumping site D2 as there is no non forest land i.e. 0.5203 ha. is available for dumping. The dumping in government land is technically feasible in all of view. Hard copy of same is enclosed herewith.
