SUB: Proposal diversion of 0.1985 Ha of forest land for construction of Kali Darshan Yatra (Footpath) at Gadi Central Pandam, Gangtok district of Sikkim by Tourism & Civil Aviation Department, Govt. of Sikkim - reply to Addl. Information reg.

Madam,

This is with reference to letter No. IRO/KOL/SK/Others/141542/2021/408 dated 22nd September, 2022, please find enclosed herewith the reply to the additional information sought for the aforesaid proposal as under:

Sl.no	Additional information sought	Reply to Addl. information
i.	Present status of the proposed footpath is not clear. What type of construction proposed in Footpath?	As informed by the User Agency, the existing track through which the people from Gadi Village travel to the temple is at a rough terrain and risky to cross due to existing high cliff. Proposed footpath shall be made of eco-friendly materials i.e stone and earth. Cement shall only be used bare minimum, for stability of footpath and safety of the pilgrims. As per information received from the User Agency existing pathway passes through difficult terrain and poses risk to tracker. Proposed footpath will be made of user friendly material that will not affect the drainage line.
ii.	Details of required area calculation along with layout map of the proposed footpath needs to be uploaded.	Area: 397m (length) x 5m (width) = 1985 sqm or 0.1985 ha or 0.49 acre. (Layout map enclosed)
iii.	Details of alternate routes explored and reasons for their rejection.	As informed by the User Agency, alternatives were explored, however due to steep gradient there is no other alternative route possible.
iv.	Since it is a non-site-specific project, justification establishing its inescapability for locating the project in forest area needs to be submitted.	As informed by the User Agency, Nishani Kali temple is a popular pilgrimage destination visited by locals and tourist throughout the year. The temple lies at the hill of Gadi giving a beautiful scenic view to the visitors thus requisite infrastructure facilitating the visitors is to boost both pilgrimage and rural tourism in the region. The temple is located within the forest area, an alternative route without the requirement of diversion of forest land could not be established. However, the proposed footpath is aligned in such a way that minimum forest land is required for connectivity.



v.	Legal status of the forest land proposed for diversion is mentioned as Reserved Forest in forwarding letter whereas it is mentioned as Khasmal by concerned DFO. It needs to be cleared.	Legal status of the forest land is Khasmal (Protected Forest). It is clearly shown on Toposheet map and Part-II details of the concerned DFO.
vi.	Compensatory afforestation proposed over 0.1985 ha degraded forest land by State Forest Department where as concerned DFO proposed over 1 ha degraded Forest land. It needs to be cleared.	Since, Compensatory Afforestation in 0.397 ha involves plantation of only 400 saplings but to ensure minimum 1 ha CA to compensate the loss of forest is proposed.
vii.	Proposed tree felling is mentioned nil in some places and 6 no. poles proposed for felling in some places. It may be cleared.	As per enumeration list 6 nos of poles (03 nos Asare, 02 nos Mauwa and 01 no Gingane) are falling in the proposed alignment.

Hence, in consideration of the additional information furnished above, you are requested to accord In-Principal approval under Section 2 of the Forest (Conservation) Act, 1980, please.

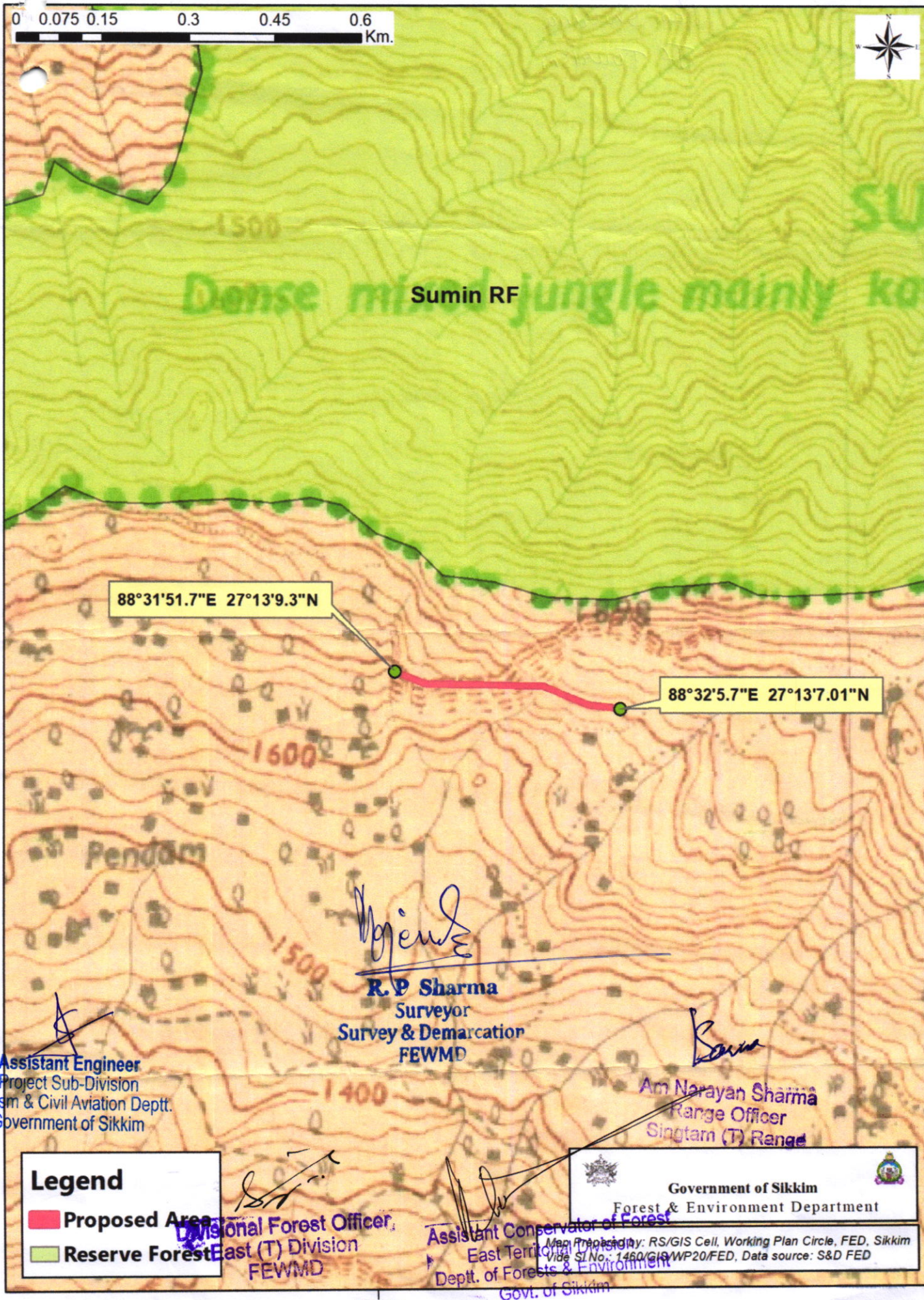
