Adverting to the reference 13<sup>th</sup> cited above, the District Forest Officer, Bhadradri Kothagudem vide reference 14<sup>th</sup> cited above has submitted that, as per the instructions of the Principal Chief Conservator of Forests (HoFF), T.S., Hyderabad vide reference 13<sup>th</sup> cited, the General Manager, M/s Singareni Collieries Company Limited, Yellandu area has submitted the following information as desired by the Government of India. MoEF & CC, New Delhi regarding the proposals for Diversion of 151.8517 Ha (earlier 106.304 Ha) of forest land for converting UG rights to surface rights for the proposed JK OC mine (JK 5OC Mine &21 Incline Mine ) at Yellandu Division in favour of M/s Singareni collieries company limited and the same is submitted as follows.

<u>Point No. i)</u> <u>Lease history of YML and YAML mining projects along-with the copies of the all earlier FC approvals/renewals granted by the MoEF&CC/RO</u>.

Further, the District Forest Officer, Bhadradri Kothagudem has submitted that, the Validity of YML and YAML will be 31.12.2034 and 31.03.2030 as per the Rule 24 (c) of Mineral Concession Rules -1960 (amended in 2021). Copies of all forest diversions granted by MoEF& CC and GO's of Mining Lease are enclosed for kind perusal.

- Point No.ii)

  As per the proposed land use 0.3510 ha area below river/Nala/canal has been proposed to be diverted. Therefore, there is a need to take the necessary permission from the concerned department of the State Govt. for diversion of said nala. In addition necessary measures/plan to mitigate the adverse impacts of the diversion of the area below river/Nala/canal is required. The same may be submitted.
- Reply: The District Forest Officer, Bhadradri Kothagudem has submitted that, the General Manager, M/s Singareni Collieries Company Limited, Yellandu area has replied that, the proposed extent of 0.3510 Ha. is to straighten the existing course of NALA within the boundary of proposed 151.8517 ha. for better utilization of proposed 151.8517 ha. Further, the NALA is very small, seasonal and the straitening work will be taken up after grant of Stage-II only. The following figure shows the existing NALA and proposed straitening of NALA



Further, the District Forest Officer, Bhadradri Kothagudem has submitted that, however, the SCCL is herewith submitting undertaking that the necessary permissions from the concerned department of State Govt. will be obtained and necessary measures to mitigate the adverse impacts of the diversion/straitening of NALA will be taken after grant of Stage-I.

In view of the above, the District Forest Officer, Bhadradri Kothagudem has requested to forward the EDS reply along with enclosures received from the General Manager, M/s Singareni Collieries Company Limited, Yellandu area to the Nodal Officer & Prl.Chief Conservator of Forests, Telangana along with the remarks to submit the same to the MoEF & CC, GoI for further action.

Therefore, based on the report of the District Forest Officer, Bhadradri Kothagudem, the EDS replies along with enclosures received from the General Manager, M/s Singareni Collieries Company Limited, Yellandu area are submitted to the Prl.Chief Conservator of Forests (HoFF), Telangana, Hyderabad for favour kind perusal and further necessary action.
