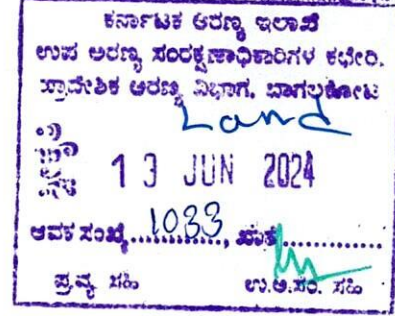

With reference to the subject forest proposal and letters under reference-5&7, the following officers were in charge of the work of "Construction of 110KV Single Circuit line on Single Circuit Towers from 220KV Mahalingapur receiving station to 110KV Sub-station Jamkhandi for a distance of 23.897", and the construction of this line was completed in the year 1987.

Further, it is learnt that the above-mentioned officers have passed away. And the addresses of their dependents are being traced. And, once the addresses of their dependents are traced and verified, the same will be communicated to Forest Department for further needful action.

Further, it is to once again submit that, the Karnataka Power Transmission Corporation Limited (KPTCL) is a Government Undertaking Company which is engaged in Construction of Sub-Stations and Transmission Lines in Karnataka State and ensures that quality and reliable power supply is provided to all the consumers in Karnataka State.

Power supply to Jamakhandi urban area, Banahatti urban area, Madarkandi, Kallahalli, Hipparagi, Kulahalli, Siddapura, Kumbarahalli, Sanala, Alaguru, Kunchanur, Jakanur, Hunnur, Kadapatti, Navalagi, Jagadala, Bandigani, Yellatti, Asangi, Bisuguppa, Banahatti Keeri and surrounding area in Jamakhandi Taluk Bagalkote District was fed from single circuit 110KV Transmission line from Mahalingapur to Jamkhandi which was commissioned in the year 1987.

At present the load in the area is increasing day by day, hence to meet the increasing load demand conversion of this single circuit transmission line to double circuit transmission line was proposed and awarded during Feb-2017. Now, except in Forest area i.e., 8.392 Kms out of 23.897Kms, all other works are completed.

This Transmission line was constructed from existing 220KV Mahalingapur Receiving Station to 110KV Sub-station Jamkhandi during the year 1987. KPTCL officials have constructed transmission line for a distance of 8.932 Kms unknowingly in the forest land as there was no demarcation of forest boundary.

During 2015 when KPTCL proposed to convert the said transmission line from single circuit to double circuit it is found that forest approval was not obtained during construction of transmission line in the year 1987. Hence, proposal is submitted to forest department for obtaining approval.

At present forest officials are requesting KPTCL to furnish the name and action taken details on the officers who have constructed the transmission line in the forest area. But the transmission line was constructed unknowingly in the forest area in good faith for providing power to the consumers of Banahatti and Jamkhandi area. The violation of Forest Conservation Act was not intentional; hence no action was taken on officers who were involved in construction activities.

Under the circumstances explained above it is clear that subject Transmission line was constructed unknowingly in the Forest land as there was no demarcation of Forest boundary and the subject sub station and transmission line was constructed in the interest of public service as explained above. However, KPTCL is ready to pay panel charges to Forest Department as per norms.

Hence, it is requested to issue Stage-I approval for the subject work without insisting on the action taken details on KPTCL officers.
