Sir,

In inviting a reference to the above mentioned subject, the compliance to Govt. of India observations dated 04.12.2023 basing on the reports of DFO, Cuttack Division and RCCF, Angul Circle are as follows:-

Observation i:- The User Agency shall pay NPV at the rate of 20 percent for each year since the violation of Forest (Conservation) Act, 1980 has commenced.

Compliance: The RCCF, Angul Circle has reported that as per demand raised by DFO, Cuttack Forest Division for Penal NPV, the user agency has deposited an amount of Rs 3,53,91,891/- (Rupees three crores fifty three lakhs ninety one thousand and eight hundred ninety one) on 15.12.2023 in ORRISA CAMPA Account No. 150825811934942 of Union Bank of India, Bengaluru vide UTR No. SBINR52023121590026110. The copy of the demand notice of DFO, Cuttack Forest Division alongwith the payment receipt are enclosed as **Annexure-I series**.

Observation ii :- User Agency shall raise Penal CA equivalent to the land utilized in violation of the provision of Forest (Conservation) Act, 1980.

Compliance: The RCCF, Angul Circle has reported that degraded revenue non-forest land over an area of 7.403 ha has been identified in village Balgopalpur under Remuna Tahasil of Nilagiri Wildlife Range of Balasore(WL) Division and the financial outlay has been approved for Rs 90,37,100/- (Rupees ninety lakhs thirty seven thousand and one hundred) only by the PCCF (FD & Nodal Officer, FC Act). A copy of the financial outlay of PCA Scheme is enclosed as **Annexure-II.**


Further, as per the demand raised by DFO, Cuttack Forest Division, the user agency has deposited an amount of Rs 90,37,100/- (Rupees ninety lakhs thirty seven thousand and one hundred) only towards Penal CA on 02.02.2024 in ORRISA CAMPA Account No. 150825811934428 of Union Bank of India, Bengaluru vide UTR NO. SBINR12024020299802724. The copy of the demand notice of DFO, Cuttack Forest Division alongwith the payment receipt are enclosed as **Annexure-III series.**

The revised CAMPA format towards deposit of compensatory levies by the user agency duly signed by the DFO, Cuttack Forest Division and countersigned by the PCCF (FD & Nodal Officer, FC Act) is enclosed as **Annexure-IV.**

In view of the above, the compliance to the observations of Government of India, MoEF & CC, New Delhi dated 04.12.2023 is sent herewith for favour of kind information and necessary action.
