In this context the point wise reply furnished by DFO Bilaspur to the observations raised vide your office online EDS under reference is as under:

Sr. No.	Observations	Answer
1.	State Government has only submitted the abstract of the 2183 proposals. State Government has not yet uploaded the remaining proposals on the Parivesh Portal for regularization of encroachments under the V(SS) A, 1980, as required within six months of the issuance of the Minutes of the AC Meeting.	The Executive Engineer, HPPWD Division No. II has reported that out of total 2183 proposals, only 59 roads of his division have already been uploaded on Parivesh Portal for regularization. The information in this regard has also been uploaded against prescribed Form-I, Part-I against additional information. (copy enclosed)
2.	Therefore, the State Govt. shall upload the remaining proposals on the PARIVESH Portal at the earliest, since the six months time period has elapsed from the issuance of the Minutes of the FAC Meeting dated 23.09.2024	In view of directions issued by FAC in its meeting held on 23.09.2024, the concerned User Agencies have been directed to upload remaining proposals on the portal immediately so that proposals can be processed accordingly.
