With reference to your letter seventh cited, I am directed to inform that "The draft notification for the project proposal of 0.62 ha in Madukkarai Forest under Section 4 of the Tamil Nadu Forest Act, 1882 for the constitution of this block as Reserved land has been received from Principal Chief Conservator of Forests, Chennai in his letter No.TS2/22375/2014, dated 11.05.2018. Further, the revised boundary description called for by the State Government has also been received from the Principal Chief Conservator of Forests C.No. TS2/22375/2014, dated 17.10.2020 and it is under process for the approval of the notification under Section 4 of the Tamil Nadu Forest Act, 1882."

2. I am therefore directed to request you to obtain the Stage-I approval from the competent authority and send the same to Government early.
