I submit to state that, based on the instructions given by the Principal Chief Conservator of Forests (Head of Department), Chennai and the Conservator of Forests, Dharmapuri in the Ref (1) and (2) cited above, the following short comings has been rectified and uploaded in the web portal in the proposal for diversion of 5.00 ha of forest land in Kesarguli Reserved Forest of Palacode Range in Dharmapuri Forest Division for formation of road from Thimmalanmedu to Kotturmalai road.

4. (i) The User Agency has uploaded necessary required 17 documents under additional information details section and the same has been furnished with authenticated hard copy of proposal. Unnecessary documents have been deleted.

- (ii) Documents uploaded under Section L-v (Scanned copy of google map for CA land), Section L-vi (Copy of Survey of India Topo sheet for CA land) and SI.No.16 (Addl. Collector letter for) and SI.No.19 (Patta) are furnished in the hard copy of the proposal.
- (iii) The defects point out under Section K-a, has been ratified and the same has been furnished in hard copy of proposal with authentication. Unnecessary document have been deleted.
- (iv) The species wise and girth class wise enumeration of trees has been uploaded in the part-II of Form-A under 4-ii for 167 numbers of spontaneous growth in nature are exist and requires felling.
- (v) (a) Compensatory Afforestation scheme has been uploaded in full shape. It also informed that, separate estimate has been prepared for both Non-Forest land and degraded forest land and same has been uploaded in the web portal to a total cost of 186.635lakhs. The hard copy of the CA scheme has been furnished in the proposal.
 - (b) The suitability certificate of the CA land has been uploaded in web portal.

(c) In the Compensatory Afforestation scheme, the estimate for maintenance of plantation has been revised for 10 years instead of 7 years. The same was uploaded in the web portal and hard copy furnished in the proposal.

- (vi) All the documents attached with the proposal were uploaded on the web portal.
- (vii) (a) As per the instructions in the Ref (1) cited above, a separate estimate has been prepared for both Non-Forest land and degraded forest land for Compensatory Afforestation scheme and furnished hard copy of the proposal. The same was uploaded in the web portal. Since there is no provision for uploading in parivesh portal, the relevant documents like topo sheet, geo reference map (KML file) of degraded forest area has been enclosed with hard copy of the proposal.
