Vide ref 10th cited, the Government of India, MoEF & CC, Integrated Regional Office, Hyderabad has sought additional information for further consideration of the proposal.

Accordingly, vide ref 12th cited, the Commissioner of Police, Rachakonda Commissionerate, Telangana has furnished information as desired by the Government of India, MoEF & CC, Integrated Regional Office, Hyderabad which are furnished as follows, with remarks:

Sl.No	Question	Reply
1	The State Government proposed 0.9009 ha out of total area 0.9714 ha is for approach road i.e.1638 mtr length with 5.5 mtr width. After scrutiny of the kml file, it is opined that the User Agency may be advised to explore alternative approach road with shorter distance. Further, it is to inform that, approach road will be exclusively used by the Police Department, hence road with 5.5 mtrs width may not be required, hence proper justification for establishing 5.5mtrs width road may be provided;	Approach road of 0.9009 Ha with 5.5 mtrs width, out of total area of 0.9714 ha is very essential to carry material in heavy vehicles, materials like aerial equipment, heavy duty batteries, repeater stations and generators etc., Moreover proposed road is safe to carry above heavy weight materials and which is safe, secure and shortest route to reach the hillock.

2	The proposed area is hillock with no facilities, but the communication tower may need power inputs such as electricity, solar or diesel engine etc. Hence it is to requested to clarify whether utilities like electricity line etc are required for the project if any. And if required is the area is falling in RF. If falling in RF, that area also requires to be included in the proposals.	The proposed area is including installation of power inputs such as electricity, solar and diesel engine etc.

Further, the UA has informed that after thorough examination there is no safe, secure alternate shortest route other than the proposed route and also installation of electricity/power inputs is within the proposed 0.9714 ha only.

In view of the above, stating the above facts the State Government are requested to submit the information to Government of India, MoEF & CC, Integrated Regional Office, Hyderabad for consideration of this proposal.

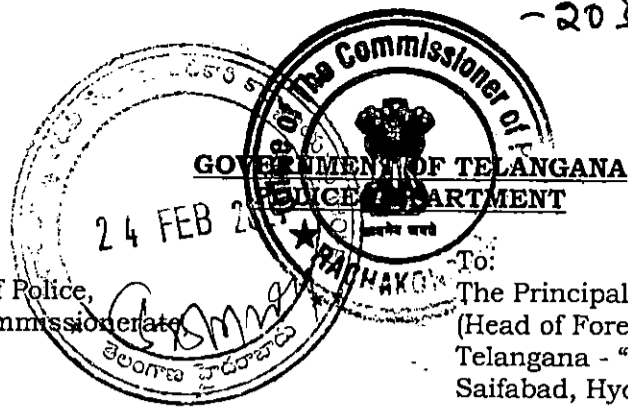

With reference to the above, as per the opinion of Principal Chief Conservator of Forests Head of Forest Force (FAC), Telangana State, we have examined thoroughly to find an alternate shortest route to reduce the proposed area and reply to the reference cited.

1. **Reply to Point No. 1 :** Approach road length with 5.5 mtrs width, total area 0.9714 ha is very essential to carry material in heavy vehicles, materials like aerial equipment, heavy duty batteries, repeater stations and generators etc., Moreover proposed road is safe to carry above heavy weight materials and which is safe, secure and shortest route to reach the hillock.
2. **Reply to Point No. 2 :** The proposed area is including installation of power inputs such as electricity, solar and diesel engine etc.

After thorough examination there is no safe, secure alternate shortest route other than the proposed route. Also we install electricity / power inputs within the proposed 0.9009 ha only.

Hence kindly approved diversion of 0.9009 ha Forest Land at Raigiri-II RF for establishment of APCO 25 tower for Phase-II network in Greater Hyderabad Police Commissionerates in Yadadri Bhuvanagiri District as requested by Government of Telangana State.
