1. As per joint verification report the non-forest land over 1.267 ha involve in this project has duly been reflected in the Site Inspection Report. Besides also the purpose wise breakup of the total land (both forest and non-forest) has been reflected over area 3.240 Ha instated of 3.257 Ha with reference to Page No.62 of the DRP submitted by the user agency is enclosed in the DP.
- 2.The user agency has submitted his compliance reflecting the non-forest area over 1.267 Ha involved in this project with reference to the joint verification report dt.8.7.2020 which is enclosed in the DP.
- 3.The C.A scheme has been duly prepared at the revised wage rate of Rs.303.40 with financial outlay of Rs.3,20,000/- which has also been reflected in the Part-II are enclosed in the DP.
- 4.On verification of land schedule both forest and non-forest land, it is seen that the same has already been signed by the DFO earlier.
