In inviting a reference to the letters cited above on the subject, this is to intimate that the Divisional Forest Officer, Athgarh Division vide Memo No. 4188 dated 23.09.2020 has submitted point-wise compliance on the observation made vide memos under reference.

iii	The consent order from State Pollution Control Board has not been furnished in the DP	The consent order from State Pollution Control Board has been enclosed at P-63 to 70/DP.
iv	The User Agency has not furnished the land use plan of the project in the DP	The land use plan of the project has been enclosed at Page-62/DP.
v	The User Agency has not furnished the tree enumeration list of non-forest land in the DP	As reported by the DFO, Athgarh there is no tree growth in the non-forest land which is enclosed at page-71/DP.

vi	The sanction order of the project has not been enclosed in the DP	The sanction order of the project has been enclosed at Page-73/DP.
vii	1.26 ha of non-forest land required for the project, accordingly the DFO, Athgarh Division has furnished the checklist No.8 by mentioning 1.26 ha of non-forest land involved in this project, but 1.284 ha of non-forest land shown in site inspection report(P-8J). So the DFO, Athgarh Division is required to provide the correct figure both in checklist as well as site inspection report.	As per joint inspection report conducted on 8.7.2020 duly signed by the Forest and Revenue Officials, the non-forest land involved in the project is 1.267 ha. and accordingly the site inspection report has been rectified by the DFO, Athgarh Division (P-8(J).
