The point wise reply of the observation/shortcomings as raised by MoEF vide letter No. FCHPB/09/174/2022 dated 05.12.2022 is as under: -

1. The extant proposal is not a non-site-specific project, it is clear from the subject title that the said proposal is for **construction of Govt. Polytechnic College Dalash**. Whereas as per Para 1.15 of FCA guidelines non-site-specific projects like industries, construction of residential colonies disposal of fly ash, rehabilitation of displaced person etc. However, the User agency has made effort to explore the pvt. Land for construction of Govt. Polytech College Dalash, but they are unable to locate pvt. Land for that purpose.
2. Since, this project is not a non-site-specific project, hence, there was no need to explore the alternative non forest land for that purpose. Whereas, Deputy Commissioner, Kullu Distt. Kullu has already issued a certificate regarding non availability of non-forest land in this regard. However, detail justification for locating the site on forest land is attached as annexure-A.
3. As per working plan of Ani Forest Division for the period 1996-97 to 2011-12 and further extended upto 31.03.2015, the area falls under improvement Working Circle. (Photocopy attached) But, erroneously in Online Part-II against Para -5, working plan Prescription has been mentioned as "Protection Working Circle" which has now been corrected in online Part-II.

Justification for the Non Availability of non-forest Land

The opening of Govt. Polytechnic College Dalash, Teh. Anni Distt, Kulluis one of the step of the State Government to meet the requirement of the Industries as well as unemployment of the state. It is pertinent to mention here that on establishment of Govt, Polytechnic College Dalash people of 14 panchayat (145 villages) of Surrounding area and about 20000 direct/ Indirectly will be benefited.


Certified that Land of 1.6868 Hectare is requires for the construction of Govt. Polytechnic college dalash which include Academic, Administrative ,Library , Workshop etc. There is no non- forest land available at Dalash Patwar circle Dalash. Whereas measuring the forest land area of 1.6868 hectare is fully Justified. Thus 142 number of trees are coming in the said proposed Govt. Polytechnic College Dalash.

Therefore 1st alternative land alignment falling 154 trees and 2nd alternative land alignment falling 180 trees. The reason behind of rejected alternative Land 1st and 2nd in due to falling higher number of trees as compare to approval alignment sight.

It is certified that the proposal Site of Construction of Govt .Polytechnic collage at Dalash . The Jurisdiction of Anni forest Division Falls well beyond the 10 K.M. radius of nearest Wildlife Sanctuary area.

Nodal officer Govt. polytechnic College Dalash .Teh. Anni Distt. Kullu. H.P. hereby undertake to pay the net present value (NPV) of the 1.6868 hectare forest land and the cost of fence post to the used in compensatory plantation to the forest Department .

This is certified that no alternative suitable land available for diversion of 1.6868 hector of non forest land (private land) for construction of Govt. Polytechnic College Dalash. Within the jurisdiction of Anni at Luhri forest division . The site which has been proposed for the above project that is approachable to the surrounding area. The maximum portion of the Forest land which had been proposed is barren land. Apart from this people have their own private land, in which apple orchard has been planted , people here have very little land so they cannot donate nearby personal land for other propose.
