Subject: **Diversion of 4.6497 hectare of forest land in favour of HPPWD for the construction of Link road from Nagali to Sanjap (Kms. 0/00 to 8/750), within the jurisdiction of Dalhousie Forest Division, Distt. Chamba, Himachal Pradesh. (Online No. FP/HP/Road/44346/2020)**

Kindly refer to your office letter No. 8B/HP/06/65/2021/FC/121 dated 29.06.2021 on the subject cited above.

2. The pointwise reply to the observations as raised by the Govt. of India is submitted as below:-

1. In this regard, it is submitted by the user agency that proposal involve 0.8397 hectare of non forest land for the construction of road. Muck dumping has been proposed on 0.2387 hectare of forest land. The local villagers have not enough land, so muck could not be disposed off in their land. Moreover, the people residing in the nearby areas are co-owners in small pieces of land. So, it is, not possible to identify private land for disposal of muck in hilly terrain. Accordingly, forest land has been identified for disposal of muck alongwith the road proposed. No felling of trees is involved in the area proposed for dumping. The vacant piece of land is suitable for disposal of muck and no felling of trees are involved in the area identified for the purpose. The clarification in this regard is enclosed herewith.
2. The comments of CWLW are still awaited. As and when are received, same will furnished to your office.
3. Certificate from DFO concerned that no plantation work has been carried out under any scheme or program in the proposed CA area earlier is enclosed herewith.
4. The Khasra Nos. of the area proposed for CA area are 4 , 297, 299 & 300.
5. Site Suitability of CA site as issued by DFO concerned is enclosed herewith.
