b) Spacing: **3X3Meter**

c) Species: local thorny and broad leaved species e.g. deshi babool, Neem, Ber, Amla etc.

d) Plantation Method: Digging pit of size 45x45x45cm and planting plants raised in near by nursery.

e) Soil and Moisture Conservation Works: - contour trenches, V-ditch, check dams etc.

f) Protection (Fencing, Watch man, People's Participation etc.): - Area will be ditch Fenced and protected by providing, Watch man and engaged by VFPMC

g) Proposed Monitoring Mechanism: - Plantation will be monitored at various level forest office in the division as well as planning and monitoring team at circle and state level.
