Accordingly, the Deputy Conservator of Forests, Chitradurga Division, Chitradurga has since been directed to obtain the CA suitability certificate in a complete form from the Deputy Conservator of Forests, Chamarajanagar Division and remaining required maps to obtain from the user agency and the submit the revised proposal for taking further necessary action in the matter.

In the light of the decision taken in the meeting held on 13-8-2019 under the Chairmanship of former Addl. Principal Chief Conservator of Forests (Forest Conservation) Bengalure, the Deputy Conservator of Forests, Chitradurga has obtained the Compensatory Afforestation land information in two parts (i) CA land information of BRT Tiger Reserve in Form B and (ii) CA lands details in respect to Chitradurga Division the degraded forest land identified double the area to be diverted i.e. 19.094 ($9.547 \times 2 = 19.094$) and as such

the CA suitability certificate has been issued in Form-C by the Deputy Conservator of Forests, Chitradurga is enclosed. Later on, the Deputy Conservator of Forests, Chitradurga Division, Chitradurga has personally visited the proposed site on 03-6-2023, after getting the area verified in conformity with the relevant maps and submitted the CA suitability in a complete form, CA Scheme, and details of KML file, Topo Map, Geo-referenced Maps to this office vide letter (3) cited above for taking necessary action.
