The justification provided for selection of forest land for this project is not convincing and further the details requested in the query such as details of alternative alignment examined, KML file/ map showing boundary of the forest land, KML file/map showing the alternative alignment examined and detailed comparative statement of forest area required under each alternative are not submitted. Thus, the State Government is once again requested to submit the above details properly along with the remarks/comments of the concerned DFO and the Nodal Officer for further processing of the proposal
