For the patches in Forest areas which are not included in the proposed diversion area and under existing Railways ROW are already marked on Railways land plans on the basis of original clothe tracing, developed during the period of British Rail companies, were already certified by M.P. State Government officials with the latest certification being in the year 2009. A total of 25 nos. of xerox copies of these certified land plans have already been submitted vide this office letter dated 22/05/2024 (ref 2 as above). Therefore, the issue of Railways'
