4.	Compensatory Afforestation has been proposed over 5.00 ha degraded forest land. Since the User Agency is State PWD, as per Forest (Conservation) Rules, 2022 Compensatory Afforestation was supposed to be proposed over equivalent non-forest land Accordingly, CA shall be proposed over equivalent non-forest land adjoining to forest land and CA details viz.
