BRIEF NOTE ON CA (NON FOREST C.A LAND) OVER AN EXTENT OF 11.88 HA. IN KAKINADA RANGE OF KAKINADA (TERRITORIAL) DIVISION.

As per the directions issued in hand book of Forest Conservation Act, 1980 guidelines communicated vide GoI, MoEF, New Delhi F.No.5-2/2017-FC, Dt.28-03-2019, and as per the special provisions of the said guidelines, Compensatory Afforestation shall be raised and maintained at the cost of user agency on Compensatory afforestation land in extent the forest land diverted in case of the projects implemented by the Central Government/PSUs and State Sector Projects implemented by the Central Government/PSUs. As per these guidelines, it is mandatory to raise Compensatory Afforestation over an extent of 11.88 ha of Compensatory afforestation Land identified in Kakinada Division in lieu of diversion of forest land of 11.30ha (6.58 ha forest land in Kakinada Division and 4.72ha. in Narsipatnam Division) for formation of road from Y.Ramavaram to Pothavaram (via) M.Bhimavaram in favour of Executive Engineer, R&B Rajamahendravaram.

The basic aim of the present scheme is to compensate the loss sustained due to the diversion of the forest land and to protect and develop in extent of Compensatory afforestation land into artificial forest with main emphasis on protection of soil from erosion through soil and moisture conservation works.
