In supersession of earlier letter no. 1741 dated 27.06.2024 of this office, I am to say that it is ascertained from the field enquiry conducted by the Revenue Inspector, Nizigarh that the Khata No. 564/110, Plot No. 2434, Area Ac. 0.320 dec., Kisam- Gharabari & Plot No. 2437, Area Ac. 0.75 dec., Kisam- Gharabari of Mouza- Madhapur are recorded in the name of Pradeep Bal Samanta, S/o- Nabaghana Bal Samanta. A concrete structure in form of building over an area of Ac. 0.067 dec. exists over plot no. 2434, rest area is lying vacant within the boundary. Similarly, a building exists over an area of Ac. 0.190 dec. over plot no. 2437, rest area is lying vacant within the boundary. However, this office is in the process filing a revision case u/s 15 (b) of OSS Act for restoring the forest land.
