Sub: Diversion of 0.10033 ha of forest land for the construction of PMGSY road from SPWD Road to Dipawalitar Upper Tumin Via Ramakrishna Mandir in East Sikkim by RDD, GoS.-reg.

Sir,

Please refer to your letter no. 1934/FCA/F&ED/391 dated 5.07.2021 on the subject mentioned above, seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980. The proposal forwarded by the State Government has been examined in this office accordance to Forest (Conservation) Act, 1980, and rules/guidelines framed there under.

I am directed to state that the State Government is requested to provide additional information for further processing of the case-

- The uploaded proposed diversion KML/Shape file has not found similar to submitted SoI Toposheet. Needs to reupload the proposed diversion KML/Shape file.
- 2) The new SoI toposheet map with starting point and end point of the road with GPS coordinated is to be furnished.
- 3) As per the site inspection report submitted by the DFO legal status of the proposed area is mentioned as Khasmal. Whereas, in online under Part-II of para 2, the proposed forest area wrongly mentioned Khesra Forest. Needs to rectify the area and legal status of the proposed diversion area.
- 4) Total period for which the forest land is proposed to be diverted has not mentioned in Part I.
- 5) As per the submitted FORM A (part-I) employment has been categorized in Skilled labour and Unskilled labour. Hence, both the categories come under temporary employment. Needs to rectify the actual employment figure in Part I.
- 6) The technically approved Compensatory Afforestation Scheme by Competent Authority of the State Govt is to be furnished.
- Certificate from Chief Secretary of the State/UT for non-availability of non-forest land for Compensatory afforestation is to be furnished.
- 8) Needs to upload "No tree felling certificate" duly singed by the concerned authorities.

The above-mentioned additional information's needs to be upload/rectify in PARIVESH portal accordingly.
