Accordingly, instructions were issued to the District Forest Officer., Kothagudem for preparation of CA scheme proposal as per the FC Act / FC Rules, 2003 as the proposal

are submitted and processed before FC Rules, 2022.

The District Forest Officer, Bhadradi Kothagudem has reported that the as per the instructions issued by the Collector & District Magistrate, Bhadradi Kothagudem vide Procs.No.E1/3171/2020, dt. 19-02-2020, the Tahsildar, Allapally has issued mutation certificate vide Rc.No.B/191/2020, dt. 21-10-2020 for an extent of 114.8625 ha in Sy.No.28 of Ulvchelka (V) & Sy.No.60 of Pedda Venkatapuram (V) of Allapally Mandal. The above land now proposed for CA is a part of the said land.

The District Forest Officer vide ref 11<sup>th</sup> cited has submitted has CA scheme proposal in NFL and Degraded Forest Land with a financial outlay of Rs.229.87240 Lakhs.

The land identified for CA is falling within the notified Rangapuram enclosure in Markode RF, which is notified U/s-15 of PA forest Act, 1967 vide GO Ms No 217, F&RD (For.III) Dept, dt.08.07.1974.

The said area is falling in Core area of Kinnersani WL Sanctuary and is covered with tree growth of species Nallamaddi, Tani, Chinduga, Buruga, tuniki, Pala, Pachara, Karangi, Teak, Revadi etc., with canopy density varying from 0.2 to 0.4 and as such cultural operations, fire tracing works, weed removal, SMC measures etc., are proposed and rejuvenation of vegetation is proposed with a financial outlay of Rs.126.16408 Lakhs.

Instead, CA is proposed in Degraded Forest Land (DFL) by retrieving forest land over an extent of 10.7249 ha under Semi Mechanical Method with 3m x 3m escapement. The details of Degraded Forest Land for raising CA with a financial outlay of Rs.103.70831 lakhs are as follows:

The District Forest Officer vide ref 7<sup>th</sup> cited has submitted CA scheme proposals for NFL for Rs.126.16408 Lakhs and for DFL for Rs.103.70832 Lakhs, totalling to Rs.229.87240 Lakhs, **which has been examined by this office / revised and finally approved for Rs. 155.623 lakhs ( Rs.75.942 lakhs for CA NFL and Rs 79.681 Lakhs for CA DFL) vide ref 8<sup>th</sup> cited copy enclosed.**

In view of the above, the above replies alongwith Part-II / revised CA scheme
