With reference to the letter 2th cited it is submitted that, the replies to
the points raised therein are furnished hereunder for necessary action.

**(I) Information in Area Statement and Certificate for CA furnished
by the User Agency i.e., Compartment numbers are not matching with
the Divisional Forest Officer's report:**

As per the information furnished by the user agency in form-A
Part –I and the proposal submitted by the Divisional Forest Officer, Narsipatnam
the subject proposal is falling in compartment no. 1241, 1242 & 1581 but not the
compartment numbers shown by the User Agency in Area Statement and
Certificate for Compensatory Afforestation.

Further, it is submitted that subject project falls under general approval category of Public Infrastructure works in LWE Districts as notified by the Ministry of Home Affairs from time to time. AS per the guidelines issued by MoEF, GoI New Delhi vide File no.FC-11/115/2019-FC, dt.13.09.2019, Compensatory Afforestation is not required towards diversion of forest land upto 5.00 ha. with less than 50 trees per ha.

(ii) The DGPS map showing the starting and ending points as the same are not shown in the DGPS map already furnished:

It is submitted that, the starting point of the road is shown at sl. no. 1 & 36 in the co-ordinates and the ending points of the road is shown at Sl. no. 34 & 35 on the co-ordinates in the DGPS authenticated map
