As per the recommendation of the Committee, Government Land are allotted. GA & PG Dept. was following the provisions of the Government Grant Act, 1895 and after repeal of Government Grants Act, GA Dept. is now following the provisions of the Odisha Government Land Settlement (Second Amendment) Rules, 2020.
