Sir,

In inviting a reference to the above mentioned subject, this is to inform that Government of India, MoEF & CC, Regional Office, Bhubaneswar has requested to furnish compliance to 2 (two) nos. of observations. The point wise compliance basing on the reports of the DFO, Baripada Forest Division and FD, STR-cum-RCCF, Baripada Circle are as follows:-

Observation (a):- The DFO, Baripada has reported that the area proposed for diversion i.e. 0.890 ha is already in use since 19.11.2003. The Hal Kissam of the area is found to be Patit (Non-forest) but, the Kissam of land as on 25.10.1980 is Jungle-I/II/ Forest. The details of action taken report on violation may be furnished.

Compliance: In compliance to above, the FD, STR-cum-RCCF, Baripada Circle has reported that the Additional District Magistrate, Mayurbhanj has submitted action taken report of Tahasildar, Baripada vide letter No. 3748/Rev dated 30.12.2024 which is enclosed as **Annexure-I**.

Observation (b):- A Site Selection Committee was held on 05.06.2002 in the office of Collector and District Magistrate, Mayurbhanj for selection of site for different projects including Mayurbhanj College of Accountancy and Management. However, who has allotted the instant proposed land has not been reported by the State Govt.

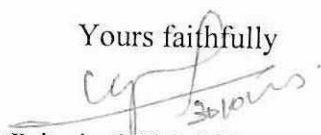

That, the following land schedule at mauza Maharajpur was approved in the District site selection committee meeting held on 05.06.2002 under the chairmanship of Collector & District Magistrate, Mayurbhanj for establishment of Mayurbhanj College of Accountancy and Management, Baripada.

Since, the hal staus of the case land was leasable in nature, a lease case bearing No-06/2002 was processed for lease of the same Govt.land at village-Maharajpur in favour of Mayurbhanj College of Accountancy & Management, Baripada on dt.5.08.2002. In the meantime, the Adminstrative approval for construction of Boundary wall was accorded by the then Collector& District Magistrate, Mayurbhanj under the scheme of MLALAD on dated 03.05.2003 in favour of the said college for the greater interest of the students. On requisition of the PA, ITDA, Baripada (the executive agency), the land was demarcated for construction of boundary wall.

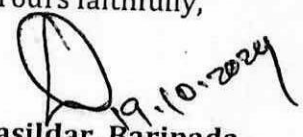
Whereas the Forest Conservation Act-1980 came into force on 25.10.1980 without any clear specification on diversion of forest land for non-forest purpose and various clarification in this regard were also issued by Revenue & Disaster Management from time to time vide Letter No. 17450 Dt. 17.06.2014, No. 22958 Dt. 04.08.2014, No- 31312 Dt. 24.10.2014 & 4822 Dt.12.02.2015. On receipt of the clarification from the Chief Secretary of Odisha vide letter No-4822 Dt. 12.02.2015, the confusion was cleared regarding diversion of forest land for non-forest purpose. Subsequently, the Sabak report was obtained from the Settlement Office on dated 06.05.2019 through the certified copy submitted by the User Agency and as per the said report the Sabak kissam of the case land is JUNGLE. So the Forest Conservation Act could not be enforced in this case at that time for the want of proper clarification in this regard. In this instant case a clarification was also sought for by the Additional District Magistrate, Mayurbhanj from the Revenue & Disaster Management vide Letter no-3170/ Rev. Dt. 07.12.2019. On receipt of clarification from the Revenue & DM Department vide Letter No-12667 /R&DM Dt. 16.03.2020 (copy enclosed), the User Agency/ Secretary of MCAM was requested to file application before the DFO, Baripada for diversion of forest land and now the Forest diversion case is under process.

Further it is intimated that, the following Officers were in charge of Tahsildar, Baripada during the period from 2002-2003 & Sri Santosh Kumar Dasbabu was the concerned Revenue Inspector during the time of Site Selection.

As the land has been kept reserved in Category I ('A' Class) in the approved master plan of Baripada Urban area, it is decided to move to the R.D.C. (C.D.) Cuttack for change of category from I to III ('A' Class to 'C' Class).

9. The committee felt that the proposed land is not suitable for construction of Office building of Independent Sporting Club, Baripada, for which the proposal is turned down.

Construction of Tourist Reception Centre :-

Tahasildar, Baripada submitted the proposal for selection of site measuring Ac 0.39 Dec. in-favour of Tourism Deptt. (Govt. of Orissa) for construction of Tourist Reception Centre at Baripada. Earlier Govt. land measuring Ac 1.000 in mouza-Bardanpur was selected in-favour of Tourism Deptt. for construction of Tourist Reception Centre in the District site Selection Committee meeting held on 2.11.98 and revalidated on 3.11.2000. Advance possession was also sanctioned in the month of November 2000. The S.D. 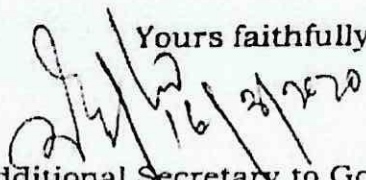

In inviting a reference to the subject cited above, I am directed to say that as per this Department G.O No. 4822/CS dated 12/02/2015 issued under the signature of Chief Secretary, Odisha, a land which has been classified as 'forest' as on 25.10.1980 is to be treated as forest irrespective of the fact that the classification has been changed to non-forest kisam subsequently by a statutory process. Where the present RoR of a land has been published after 25.10.1980, the old RoR has to be referred to in order to ascertain if such land was forest as on 25.10.1980. And if the land was forest as on the date 25.10.1980, Forest (Conservation) Act, 1980 will be applicable and forest diversion has to be done accordingly.

2. In the present case, though the process of settlement operation started from 1975, the final RoR was published during 1985 i.e. after 25.10.1980. So, as per the circular issued by Chief Secretary, the old RoR has to be referred to. In the old RoR i.e. in the Sabik record, the kisam of the land was forest. Thus, FC Act, 1980 will be applicable in the present case.

3. You are, therefore, requested to advise the College authorities to apply before the Nodal Officer authorized by the State Government to deal with forest conservation matters under the FC Act, 1980 by following due procedure as prescribed in rule 6 of the FC Rules, 2003 to use the forest land in question for non-forest purpose. This shall be subject to the condition that the user agency

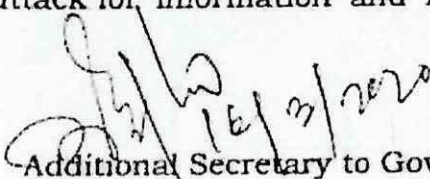
i.e. Mayurbhanj College of Accountancy & Management (MCAM), Baripada shall provide required extent of land for compensatory afforestation purpose which is to be mutated in the name of Forest & Environment Department. On the other hand, if the user agency is unable to provide such land and if suitable Govt. land is available, Revenue & D.M. Department may provide such required land to the user agency for compensatory afforestation purpose subject to payment of premium of the land by the user agency.

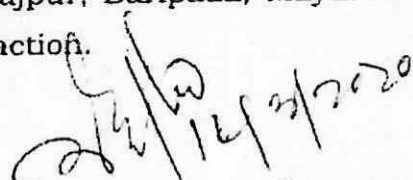

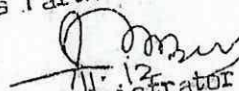

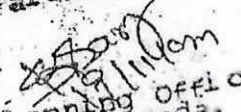

Sub:- Change of classification of land in the Record of Rights.

Madam/Sir,

I am directed to invite a reference to Letter No.44019/R&DM, dated 23.11.2013 and Letter No.17450/R&DM, dated 17.06.2014 regarding applicability of provisions of Forest Conservation Act, 1980 to land(s) recorded as 'forest' in the Record of Rights (RoRs) that existed prior to 25.10.1980 i.e. Sabik RoR and subsequently classified as 'non-forest' in the Hal RoRs on the basis of the nature, character and use of the land before the said Act came into force.

The Forest Conservation Act, 1980 (FC Act) has been enacted with a view to checking further deforestation, and seeks to operate in respect of forest land which existed as on 25.10.1980. It may be noted that the change of RoRs is a well established continuing statutory process. Accordingly, changes are reflected in the RoRs prepared during the settlement operations which take place at considerable gaps of time i.e. 30-40 years. As per provisions u/s 13(3) of the Orissa Settlement Act, 1958, if any entry in the RoRs is altered in subsequent RoRs, the later has to be presumed to be correct until it is proved by evidence to be incorrect, but the previous entry can be admissible as evidence of facts existing at the time such entry was made. In case required for a project, the status of land classified as 'forest' on 25.10.1980 is to be diverted for non-forest use after obtaining prior approval of Central Government as per provision of the F.C.Act.

Hence, where the present RoR has been published after 25.10.1980, the old RoR may have to be referred to find out the forest land required to be diverted for non-forest purpose and Forest Diversion Proposal (FDP) is required to be processed accordingly. If old RoR is not available in cases where RoR is published after 25.10.1980, the status of land classified as 'forest' as on 25.10.1980 needs to be ascertained as per the current RoR and other records available with Tahasildar while preparing FDP. While preparing land particulars for FDP, a certificate as suggested below may be furnished by Tahasildar/Addl.Tahasildar to facilitate decision on the FDP.

"Certified that status of total land involved in the project (both forest & non-forest) as given in the Table below is as per Government records as on 25.10.1980".

The land related information relating to FDP of different projects/proponents should be processed and furnished as quickly as possible.

Sub: Clarification regarding classification of land in the RoR.

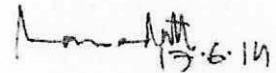
Sir,

I am directed to invite reference to the last paragraph of this Department's letter No.44019/R&DM, dated 23rd November, 2013 on the aforementioned subject, wherein it was stated that "lands included within the list filed before the Hon'ble Apex Court may be treated as forest land and which are not included in the list may be treated as non-forest land".

2. The legal and constitutional provisions in regard to "forests" vis-a-vis the judgement rendered by the Hon'ble Apex Court in T.N. Godavarman Thirumulkpad Vrs. Union of India have been examined again in consultation with the legal experts, and as advised by them, the said paragraph is substituted as follows:

"In view of the affidavit filed by the State Government in WP(C) No.202/1995, lands included in the list filed before the Hon'ble Supreme Court may be treated as forest land. If the lands are not covered under the said affidavit, but if in fact, they satisfy the description of "forest", the same shall be treated as forest".

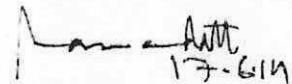
