In compliance to the reference 6th cited it is submitted that the Use agency has prepared 3.07 ha of non-forest land in two bits (lieu 2.96 Ha of forest land proposed for diversion) Bit-I, 2.77 Ha and Bit-II-0.30 Ha. The distance between these two Bits is 111.58 mts. The smaller Bit is of 0.30 ha area and there is every possibility for encroachment in future seems to be high. **The Status of land between these two Bits is not clear.**

Further it is submitted that the land in between these two bits located in Dhone Range is the CA land to an extent of 2.61 ha identified in lieu of diversion of 2.59 ha of Forest land in Comp no 313 of G.A. Bad beat during 2020 vide GOI, MOEF & CC, IRO, C, IRO, Vijayawada Ly F.no 4-APB 082/2018/CHN7 of 22.12.2020 by the same User Agency i.e., M/s GMR Stone Crushers Ltd. (Prop G. Maddilety Reddy, R/o Banaganapalli). Hence, all the above 3 Bits are contiguous and located adjacent to comp.no.209 of Devagudipadu RF of Peddapaya Beat. Hence, there may not be any Problem in management point of view and also there

may not be much scope for encroachment in future also. Further, the proposals for notification of 2.61 ha of CA land already handed over to the Forest Department in lieu of Diversion of 2.59 ha of Forest land under Section 24 of A.P., Forest Act, 1967 is under progress.

It is further submitted that, while processing the proposals, the then DFO, Kurnool has also inspected the proposed CA lands of two Bits on 04.01.2021 and recommended that the proposed two CA Bits (Bit-I, 2.77 Ha & Bit-II, 0.30 Ha) identified for this Project are suitable from management and protection Point of view and the CA land identified is not overlapped with the Non-forest land (CA land) already identified for other projects. A copy of the field inspection notes issued by the then DFO, Kurnool is enclosed herewith for ready reference.

It is further submitted that the following pointwise replies are submitted herewith for favour of kind perusal and necessary action.

Director Mines & Geology Kurnool. After obtaining the clearance from the above two Departments on 11.10.2023 and 2.11.2023 respectively; the DFO, Nandyal has accorded working permission in Proceedings Rc. No 2681/2017/A4 Dt 3.11.2023 and the mining activity in the subject area of 2.59 ha was started after 03.11.2023 and the same is under progress and the delay is not intentional.</p> <p>In this connection it is submitted that, as per the report of Forest Range Officer, Banaganapalli Range, FRO along with the concerned staff inspected the subject mining area on 21.11.2025 and noticed that the mining is under progress, the reply of the User agency is that, the delay caused in mining is due to delay in obtaining permission from various departments.</p>

No non forest use of such forest lands falling within the lease shall be allowed, for which approval under afore mentioned clause of the Adhinyam has not been obtained by the State Government. ORDER:

In the letter first read above, the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, has submitted a proposal under Forest (Conservation) Act, 1980, for diversion of 2.59 Ha. of forest land in Compt.No.313 of Gulamaliabad South RF, Dhone Range, Kurnool Division for grant of quarry lease for road metal in favour of M/s.G.M.R.Stone Crushers, (Prop. Sri G.Maddilety Reddy) Banaganapalli and requested to forward the same to Government of India, Ministry of Environment, Forests, & Climate Change, Regional Office, Chennai for according necessary approval under Section-2 of Forest (Conservation) Act, 1980.

2. In the letter 2nd read above, the proposal of the Principal Chief Conservator of Forests was sent to Government of India, Ministry of Environment & Forests, Regional Office, Chennai for their approval under Section-2 of Forest (Conservation) Act, 1980.

3. In the letter 3rd read above, the Government of India, Ministry of Environment & Forests, Regional Office, Chennai have accorded in-principle (Stage-I) approval under Section-2 of Forest (Conservation) Act,1980, for the proposal, subject to compliance of certain conditions as stipulated therein. Accordingly, in the letter 4th read above, the State Government furnished compliance report on the conditions stipulated by the Government of India, Ministry of Environment & Forests, Regional Office, Chennai while according in-principle (Stage-I) approval.

4. In the letter 5th read above, the Government of India, Ministry of Environment, Forests & Climate Change, Integrated Regional Office, Vijayawada have accorded (Stage-II) approval under Section-2 of Forest (Conservation) Act, 1980, for diversion of 2.59 Ha. of forest land in Compt. No.313 of Gulamaliabad South RF, Dhone Range, Kurnool Division for grant of quarry lease for road metal in favour of M/s. G.M.R.Stone Crushers, (Prop. Sri G.Maddilety Reddy) Banaganapalli, subject to certain conditions as stipulated therein.

5. After careful examination of the proposal, the Government hereby accord permission to the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, for diversion of 2.59 Ha. of forest land in Compt. No.313 of Gulamaliabad South RF, Dhone Range, Kurnool Division for grant of quarry lease for road metal in favour of M/s. G.M.R.Stone Crushers, (Prop. Sri G.Maddilety Reddy) Banaganapalli, subject to the following conditions:-

1. Legal status of the diverted forest land shall remain unchanged;

2. The demarcation of the forest area proposed for diversion shall be carried out by erecting 4 feet high concrete pillars duly numbered at an interval of 20 mtrs at the cost of User Agency. The User Agency shall ensure demarcation of boundary of safety zone (7.5 meter strip all along the boundary within the mining lease area);
3. Compensatory afforestation over identified non-forest land of 2.61 ha in Sy.No.98/1, 98/2, 98/3, 98/4 of Kommemarri (V) of Peapully Mandal, Kurnool District, shall be raised and maintained by the State Forest Department from the funds already realized from the User Agency;
4. A minimum of 1000 plants / ha of diverted forest area shall be planted in the identified CA land. In case, the required numbers could not be planted therein, the balance shall be planted in the nearby RF/FF by the State Forest Department at the cost of the User Agency;
5. The mutated non-forest land in favour of the State Forest Department for the purpose of compensatory afforestation shall be declared as Reserved Forest under Section-4 or Protected Forest under Section-29 of the Indian Forest Act, 1927 or under the relevant Section(s) of the State Forest Act. The Nodal Officer shall report compliance within a period of six months from the date of grant of final approval and send a copy of the original notification to this office for information and record;
6. The approved compensatory afforestation scheme shall not be changed without prior approval of the Central Government;
7. Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from the User Agency;
8. In case the mining lease is adjoining habitation, the stretch of the boundary of the safety zone of the lease adjacent to the habitation/roads should be properly fenced by the User Agency at the project cost to protect the vegetation/regeneration activities in the safety zone;
9. Safety zone shall be maintained as green belt and to ensure dense canopy cover in the area, regeneration activity shall be taken up by the State Forest Department from the amount already been realized from the User Agency;
10. The State Forest Department shall carry out afforestation and its maintenance on degraded forest land over 1.036 ha (one and half times the extent of safety zone) in Compt No.186, Kothaburuju RF, Malysala Beat, Dhone Section of Dhone Range from the amount already been realized from the User Agency;
11. The State Forest Department shall undertake gap planting and soil & moisture conservation activities to restock and rejuvenate the degraded open forest (having crown density less than 0.4), if any, located in the area within 100 meters from outer perimeter of the mining lease using native species, from the amount already been realized from the User Agency;
12. The User Agency shall undertake mining and concurrent reclamation in a phased manner as per the approved mining plan, and submit an annual compliance report to the Integrated Regional Office, Vijayawada. If it is found that the activities indicated in the reclamation plan are not being executed by the User Agency, the State Government or the Regional Office, IRO Vijayawada may direct that the mining activities shall remain suspended till such time, such reclamation activities are satisfactorily executed;
13. The User Agency shall ensure stabilization of the overburden dumps by appropriate grading/ benching so as to ensure that angle of repose at any given place is less than 28° ;
14. Diversion of the said forest land under this approval shall be for a period co-terminus with the period of the mining lease proposed to be granted under the Mines and Minerals (Development and Regulation) amendment Act, 2015, or Rules

framed there under. The User Agency shall submit a copy of the Mining lease once obtained, to the Integrated Regional Office, Vijayawada for record;

15. The User Agency shall obtain Environment Clearance as per the provisions of the Environmental (Protection) Act, 1986;
 16. Consent of the State Pollution Control Board shall be obtained under the Air and Water Act before commencement of mining operations and it shall be renewed regularly;
 17. No labour camps shall be established on the forest land. The User Agency shall provide firewood, preferably alternate fuel to the labourers and the staff working at the site so as to avoid any damage and pressure on the adjacent forest areas;
 18. Only temporary storage sheds shall be set up in the area and no permanent structure shall be constructed;
 19. The layout plan of the proposal shall not be changed without prior approval of the Central Government;
 20. The User Agency and the State Government shall ensure compliance to all the Acts, Rules, Regulations and Guidelines of the Ministry, for the time being in force, as applicable to such project;
 21. The forest land shall not be used for any purpose other than that specified in the proposal and total forest area utilized for the project shall not exceed 2.59 ha (including safety zone area).
 22. The forest land proposed to be diverted shall under no circumstances be transferred or sublet to any other agency or Department or person without prior approval of the Central Government;
 23. The Principal Chief Conservator of Forests & HoFF, Andhra Pradesh shall ensure that the approved CA scheme is implemented in its entirety and the CA plantations are maintained for 10 years as per the approved CA scheme. Suitable instructions may be issued to the field officers in this regard and if need be, the PSR may be suitably modified to facilitate this;
 24. Any other condition that the Regional Officer, IRO Vijayawada may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area shall be complied by the User Agency;
 25. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per prescribed in para 1.21 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC, dated 28.03.2019;
6. The Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, shall take further necessary action in the matter accordingly.

Through the reference 1st cited, the District Mines and Geology officer, Kurnool has granted a Quarry Lease for Road Metal over an extent of 2.597 Hectares in Compartment No: 313 of Gulamaliabad, South Block, R.F Dhone Range, Bhanumukkala Village, Banaganapalle Mandal, Nandyal District for a period of "15" years in favour of M/s GMR Stone Crushers, Prop: Sri G. Maddilety Reddy.

In the reference 2nd cited, this office has requested the grantee to submit all required documents and to attend for execution of the Quarry Lease Deed within the stipulated time.

Accordingly through the reference 3rd cited, the grantee submitted the required documents copies, i.e., EC, CFE, AMP., and etc., and also paid the necessary advance rentals, Security Deposit amounts, and requested to execute the Quarry Lease deed in-favour of M/s GMR Stone Crushers, Prop: Sri G. Maddilety Reddy.

Therefore, the Quarry Lease Deed is executed in Form - G today i.e. 21.11.2023 in favour of M/s GMR Stone Crushers, Prop: Sri G. Maddilety Reddy for Road Metal over an extent of 2.597 Hectares in Compartment No: 313 of Gulamaliabad, South Block, R.F Dhone Range, Bhanumukkala Village, Banaganapalle Mandal, Nandyal District for a period of "15 (Fifteen)" years with effect from 21.11.2023 to 21.11.2038.

The lessee is hereby permitted to commence the Quarry operation for Road Metal mineral in the subject area, as per APMMC Rules 1966 and the rules to be amended from time to time. The Lessee has to submit opening notice in Form-C before commencing quarry operation.

The lessee should produce invariably all the accounts, registers, documents, records etc., in connection with the subject lease held by 5th April of every year before the Divisional Mines & Geology Officer, Banaganapalle and pay the Dead rent on or before last working day of February in every year in Advance.

The lessee should submit the Half yearly returns in Form 'P', and Annual return in Form 'Q' to the Director of Mines and Geology, Ibrahimpatnam, to the District Mines & Geology Officer, Nandyala / Kurnool & Divisional Mines & Geology Officer, Banaganapalle as required under MCDR 1988, and also follow the Explosives Rules, 2008 and Mines Safety Rules as per MMR 1961. Further, the lessee shall submit Consent for Operations (CFO) before starting Quarrying Operations.

Further, the grantee shall pay Seigniorage Fee / DMF / MERIT and also pay the consideration amounts well in advance, and obtain dispatch permits through Online from the Divisional Mines & Geology Officer, Banaganapalle before transporting the material from the leased area. The lessee should abide the conditions in the Annexure appended to the Grant order scrupulously.

MADDILETY REDDY, S/O G. RAMA SUBBA REDDY, H.NO:2-41, FORT AREA, BANAGANAPALLE VILLAGE AND MANDAL, NANDYAL DISTRICT** (Here-in-after called the "Lessee" which expression shall, where the context so admits include his heirs, executors, administrators, representatives and assigns) of the other part.

1. Whereas the Lessee has been granted of a quarry lease by the Government of Andhra Pradesh on application in of the lands in the Nandyala (Erstwhile Kurnool) District for the purpose of quarrying for Road Metal and has deposited with the Divisional Mines & Geology Officer, Banaganapalle (FAC) the sum of Rs.5,06,415/- paid through Challan No.71359808662023, Dated: 30.10.2023 of CFMS Portal as security for the due and faithful performance by the lessee of the covenants and conditions on the part of the Lessee hereinafter contained.

And whereas the Government of Andhra Pradesh acting for and on behalf of the lands and premises hereinafter described and demised for the term and at the dead rent and scignorage fee, and subject to the covenants and conditions hereinafter contained now this indenture witnesses as follows:-

(9) That the Lessor's agents, servants and workmen shall be at liberty at all reasonable times during the said term, to inspect and examine the works carried on by the Lessee under the liberties herein before granted and the lessee shall and will, from time to time, and at all times during the said term hereby granted conform to observe all orders and regulations which the Lessor or his authorized agent as the result of such inspection may from time to time see fit to impose to keep the lands in good and substantial repair, order and condition or in the interest of public health and safety.

The Government of India vide reference 1st cited, has conveyed their approval i.e. stage-I under section-2 of Forest (Conservation) Act, 1980 for diversion of 2.597 ha. of forest land for grant of quarry lease for road metal in Compt. No.313, Gulamaliabad South Reserve Forest of Banaganapalli Range of Nandyal division (erstwhile Dhone Range of Kurnool division) and Nandyal district. In connection with quarry lease of road metal in favour of Sri G.Maddilety Reddy R/o Banaganapalli Village & Mandal.

Subsequently, the Government of Andhra Pradesh vide reference 3rd cited, has accorded permission (stage-II) approval for diversion of 2.597 ha. of forest land in Compt. No.313, Gulamaliabad South Reserve Forest in Banaganapalli Range of Nandyal division (erstwhile Dhone Range of Kurnool division) in Nandyal district, in connection with grant of quarry lease for road metal in favour of Sri G.Maddilety Reddy R/o Banaganapalli Village & Mandal for a period of (15) years i.e., 02-11-2023 to 01-11-2038 subject to certain conditions stipulated therein and also stage-II conditions applicable.

As per the condition laid down in the Government orders 1st cited, the user agency has paid an amount of Rs.16,25,722/- (Rupees Sixteen Lakhs Twenty Five Thousand and Seven Hundred Twenty Two only) towards Net Present Value (NPV) and towards Compensatory Afforestation of Rs.24,67,200/- (Rupees Twenty Four Lakhs Sixty Seven Thousand and Two Hundred only) and paid towards Safety Zone of Rs.3,35,300/- (Rupees Three Lakhs Thirty Five Thousand and Three Hundred only) Rs.5,02,950/- (Rupees Five Lakhs Two Thousand Nine Hundred and Fifty only) towards afforestation in degraded forest land of one and half times the extent of Safety Zone and Rs.4,22,000/- (Rupees Four Lakhs and Twenty Two Thousand only) towards

Hence, the lessees are hereby permitted to commence the mining operations after taking charge of the proposed area of 2.597 ha. from the Forest Range Officer, Banaganapalli subject to the following conditions.

- 1) Legal status of forest land shall remain unchanged.
- 2) The demarcation of the forest area proposed for diversion shall be carried out by erecting cement concrete pillars duly numbered at an interval of 20 meters at the cost of user agency.
- 3) The Compensatory Afforestation shall be raised over 2.61 ha. of identified non-forest land in Sy.Nos.98/1, 98/2, 98/3 and 98/4 of Kommemarri Village of Peapully Mandal in Nandyal district at the cost of user agency. The State Government shall obtain prior permission of Central Government for change of location and schedule of Compensatory Afforestation site, if any.
- 4) The non-forest land for Compensatory Afforestation shall be notified by the State Government as PF / RF under Indian Forest Act, 1927 or the State Forest Act and Nodal Officer (FCA) shall report the compliance within six months.
- 5) The State Government shall maintain area upto 7.5 meters as Safety Zone area all along the boundary as per the guidelines issued under Forest (Conservation) Act, 1980 at the cost of user agency. The State Government shall also raise and maintain the plantation over an area, one and half times of the extent of the Safety Zone in degraded forest land elsewhere at the project cost.
- 6) Adequate care shall be taken to check any rolling of over-burdens / dumps beyond diverted area and also to check soil erosion due to mining activities.
- 7) The quarrying shall be carried out by providing benches to avoid steep slopes.
- 8) The forest area shall be used for the purpose of mining, storage of materials and OB dumps only. No permanent buildings or labour sheds shall be constructed in the leased area.
- 9) Reclamation plan shall be implemented by user agency from the very first year of mining and an annual report shall be sent to the Nodal Officer, Andhra Pradesh and the Regional Office, Vijayawada.
- 10) The consent of Andhra Pradesh Pollution Control Board (APPCB) shall be obtained under Air and Water Act before commencement of mining operation and it shall be renewed annually.
- 11) Additional amount of the Net Present Value (NPV) of the diverted forest land if any becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from the user agency and deposited through RTGS e-challan in AP State CAMPA fund.

- 12) User agency shall obtain environmental clearance under the Environment (Protection) Act, 1986.
- 13) A comprehensive monitoring shall be done at the end of five years to study the impact of mining on the surrounding flora and fauna and its watershed. If it is found that the lessee has violated or is not complying with the stipulated conditions, then the approval given under the Forest (Conservation) Act, 1980 shall be revoked.
- 14) The total forest area utilized for the project shall not exceed 2.597 ha. handing and taking over of land and commencement of work in the land shall be done within a period of two years from the date of stage-II approval.
- 15) Any other condition that the Regional Officer, IRO, Vijayawada may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area shall be complied by the user agency.

with reference to letters cited, and in response to ref 6th cited, I submitted here with detailed and Comprehensive report on the points arose in Govt ref 1st & 2nd Cited duly after inspecting the work spots Point wise as detailed below.

It is submitted that in ref 1st & 2nd cited above, Under Para 1, it is arose that the U.A has prepared 3.07 Ha of non-forest land in two bits (lieu 2.96 Ha of forest hand proposed for diversion) Bit-I, 2.77 Ha and Bit-II-0.30 Ha. The distance between this two Bits is 111.58 mts. The smaller Bit is 0.30 Ha area, which is very small, there is possibility for encroachment in future seems to be high. The Status of land between this two Bits is not clear.

Further I came to know that the CA land in between these two bits located in Dhone Range as CA land for 2.59 ha of forest land leased out for mining of road meatal in Compt No.313 of Gulamaliah bad RF by the same U/A i.e. M/s GMR Crushers stone ltd. (Prop G. Maddilety Reddy, R/o Banaganapalli.

In this regard, I submit that the proposed CA land in two Bits is located in Dhone Range. Hence I have obtain information, that in between the above two proposed CA Bits earlier the same user agency has handed over & Mutated 2.61 Ha of non-forest land to forest dept for CA in & Forest land diverted in Comp no 313 in lieu of 2.59 Ha in G.A. Bad beat during 2020 vide GOI, MOEF & CC, IRO, C, IRO, Vijayawada Ly F.no 4-APB 082/2018/CHN7 of 22.12.2020, So all the above

3 Bits are Contiguous and located adjacent to comp.No.209 of Devagudipadu RF, Peddapaya Beat. Hence there may not be any Problem in management point of view and also may not give much scope for encroachment in future also. Further the notification proposals. Under APF Act 1967 for 2.61 ha of CA land already handed over to This Dept in lieu of 2.59 Ha of Forest land diverted are under progress.

While processing the proposals, the then DFO, Kurnool has also inspected the proposed CA lands of two Bits on 4-1-2021. A copy of the field inspection notes of the then DFO, Kurnool enclosed to the proposals is enclosed for ready reference, wherein it is clearly recommended that the proposed two CA Bits (Bit-I, 2.77 Ha & Bit-II, 0.30 Ha) identified for this Project are suitable from management and protection Point of view and the CA land identified is not overlapped with the Non-forest land (CA land) already identified for other projects. further at Para 2 & 3 of above ref 1st & 2nd cited Certain (3) points are raised for more clarification and requested to submit requisite information. Accordingly, I am here with submitting requisite information for all the (3) Points, as follows point wise.

Point (i):- No proper explanation is provided by the user Agency for diverting more forest land for mining when the existing diverted area is kept unused since 2020.

In response to above, the user Agency has replied that the existing diverted forest land for mining is in 2.59 Ha area for mining in favour of the same user Agency of the subject proposal during 2020 Could not be started for mining till 3.11.2023 is mainly due to delay in obtaining clearance from Pollution Control Board and also delay in granting mining lease by the Dy. Director Mines & Geology Kurnool. After obtaining the clearance from the above two Departments on 11.10.2023 and 2.11.2023 respectively, the DFO, Nandyal has accorded working permission in Proceedings Rc. No 2681/2017/A4 Dt 3.11.2023 mining activity in the existing diverted Forest area 2.59 Ha was started after 3.11.2023, since then mining in this existing mine is under progress, but not delayed intentionally.

Further, I submit that I have also inspected this existing mining area of 2.59 Ha in Comp. No 313 G.A. Bad RF along with staff Concerned on 21.11.2025 and noticed that the mining is under progress. The delay caused in mining in this existing area 2.59 ha is due to delay in obtaining permission from various departments.

Point (ii):- Linking the present diversion area With the previously diverted 2.59 Ha area for the purpose of forest Road might create fait accompli situation in future.

In this regard I submit that the map showing the location of Mining leases granted by the Govt of India around the proposed subject mines of 2.96 Ha in Compt No. 313. G.A. Bad RF Banaganapalli Range duly marking the roads leading to various mines for Transport of mined material i.e, cluster mining map is enclosed for perusal.

It can be seen from the mining cluster map enclosed, that the mining locations named as "C, F & G" either approved or proposals under process are by one Name i.e GMR stone Crushers (pro:- G. Maddilaty Reddy)

The mine location named as "C" in the map, the GOI have approved for mining lease in 2.56Ha area during 2012 vide GOI Ly no 4-APB 718/2010.BAN/1942 Dt 3.10.2012 for a period 10 years. The ruining lease Period was expired by 2024.

Similarly, the mine location named as "F" in the map enclosed, the GOI have approved for mining lease over an area of 2.59 Ha during 2020 vide GOI Lr no 4-APB 082/2018-CHN/7, Dt 22.12.2020 for Period of 15 years is now under operation.

The other location named as "G" in the map, Proposals for diversion of 2.96 Ha area are under process. This Proposed mine in 2.96 Ha area is located at adjacent to already approved and existing mine which is at northern side of 2.59 Ha area approved in favour of M/S GMR stone crushers.

Hence the existing approach road covering 0.11 Ha area which is leading to existing mine 2.59 Ha can be used to the newly proposed 2.96 Ha area also by crossing through 2.59 Ha "(F)" as the user agency is one for 2.59Ha area and 2.96 Ha are now proposed till the lease period of 2.59 Ha "(F)" is expired. As per Govt of India guidelines minimum forest area shall be utilized for roads depends on requirement.

Further, it is submitted that there is requirement, further it is no alternative road except above to transport mined material from the proposed area of 2.96 Ha. Hence transport of mined material from 2.96 Ha area through 2.59 Ha already approved mine in the name of same owner may be considered.

Point (iii):- The above minimum requirements of forest land is not Justified as earlier diverted land is not operated till now.

The user agency has submitted that they are un-able to meet the present demand in supply of road metal to the both Government and public sector like National Highways, state Highways, Railway projects, Irrigation projects etc. are in progress around Kurnool and Nandyal District in A.P.

Further, It is submitted that as per instructions issued In Chapter-7, Mining projects stated that "Mining Operations will be restricted to the forest area for which approval under clause (ii) of subsection (1) of section 2 of the Adhiniyam has been obtained by the erstwhile user agency. No non forest use of such forest lands falling within the lease shall be allowed, for which approval under aforementioned clause of the Adhiniyam has not been obtained by the State Government. Mining in such areas may be allowed only after obtaining prior approval of the Central Government under the aforementioned clause of the Adhiniyam.

This is submitted for favour of information and necessary suitable action.

On 04/01/2021, I along with Forest Range Officer, Dhone and concerned staff inspected the non forest land identified in two bits - Bit 1-2.77 ha & Bit II - 0.19 ha in Sy No.98/1, 98/2, 98/3 & 98/4, Konnenarri village, Peapalle Mandal, Kurnool District for Compensatory Afforestation in lieu of land proposed for diversion of forest land over an extent of 2.96 ha in Gulamaliabad South RE Compartment no 313, GA Bad Beat, Dhone Range of Kurnool Division for grant of quarry lease for Road Metal in favour of Sri G.Maddilety Reddy, R/O Banaganapalli.

The user agency had completed the DGPS survey of the non forest land identified in the said location and the same has been verified and authenticated by the Principal Chief Conservator of Forests, Andhra Pradesh, Guntur Circle, Ref.No LFSC/1580/11/2016, W.A.C. P/CF/1/A/2/10/2016, dated 10/01/2021 and the area assessed is 2.97 ha. The CA land identified in two bits are adjacent and contiguous to Compartment no. 209, Devagadipadu Reserve Forest and the soil is Red soil and suitable for raising of plantation with forest species and the site is suitable from management and protection point of view. Further, the CA land identified under this project does not overlap with the non forest land identified for other projects. The CA area should be raised under Semi-Mechanical Method and the plantations maintained upto 19 years to ensure good results.




Fig. 1: Dam at Konnenarri village




