Subject : **Diversion of 1.8272 ha. of forest land in favour of HPPWD for the construction of link road Chowk to Sandoa via Dharjol Ropari Dhar (km 0/00 to 4/810) within the jurisdiction of Suket Forest Division, Sundernagar, Distt. Mandi, HP. (Proposal No. FP/HP/road/40734/2019).**

Kindly refer to Government of India MoEF and CC Integrated Regional Office Shimla letter No. FC/HPB/06/22/2021 dated 29/12/2022 on the subject cited above.

2. In this context, the point-wise observations as desired vide above referred communication is as under:-

1. The user agency submitted that all consultation and meetings of FRC of Sub-Divisional Level Committee of village Dharjol as well as records of consultation and meetings of Gram Sabha of concerned villages the following documents have also been uploaded:-

(i) A copy of records of consultation and meetings of FRC of Sub Divisional Level Committee of Village Dharjol have now been uploaded in Part-I additional information.

(ii) A copy of records of consultation and meetings of Gram Sabhas of concerned 05 villages have now been uploaded in Part-I additional information.

2. In this connection, user agency submitted that 0.9049 ha. non forest/private land area has also been included for which the copies of sale deed/gift deeds/ affidavits made in favour of HPPWD by the private land owners have now been provided/uploaded additional information details in Part-I.

3. The user agency submitted that the dumping sites in the proposal has been proposed on private/ non-forest land and the affidavit in this regard has been uploaded against additional information details in online Part-1. The following documents have also been uploaded:-


(i) The Muck Management Plan (MMP) and detail of measurement of muck/debris to be generated in the project have also been uploaded in Part-I Additional Information.

(ii) In Muhal Dharjol/32 and Sandoa/223, Khasra No. 493 and 322 have been donated for the dumping site by the concerned private landowners i.e. Sh. Himmat Ram S/o Sh. Purbia Ram Muhal Dharjol has an area of khasra No. 493 of 0.1053 ha. out of which 0.0800 ha. is being donated for the dumping site and Sh. Yograj Sharma S/o Sh. Hans Raj Muhal Sandoa has an area of khasra No. 322 of 0.7523 ha. out of which 0.0800 ha. is being donated for the dumping site. Revenue Nakal Jambandi detail has been uploaded Part-I in PARIVESH Portal.

4. In this connection, RFO Sarkaghat submitted Soil & Moisture Conservation Plan and same has been uploaded in Part-II additional information in PARIVESH Portal.

5. The user agency submitted that the village Dharjol is a cluster of various inhabitation situated 0.500, 1.000, 1.500 Km far from each other. It is clear by the KML file that another link road is existing from Geo-Reference $31^{\circ}43'27.87/76^{\circ}44'39.06$ which cover only one inhabitation and it leads from on carrier of village dharjol to down word of south direction up in the proposed road of geo-reference $31^{\circ}43'2.23/76^{\circ}44'49.97$ but this road does not attract the FCA provision because this path/road used to be very ancient, which was used for grazing cattle/mule path and for drinking water. This road is not a part of proposed road in any way.
